The fee can be paid either as "Foreign Currency Demand Draft" favoring "Comptroller, GADVASU", payable at any scheduled bank in Ludhiana or as Bank Transfer (Swift transfer) as per the details given in Sr. No. 5.4 (b) of Chapter-V

#### **General Information**

- (i) Candidates may download the prospectus from the university website (www.gadvasu.in) and should carefully read the eligibility criteria, admission rules, etc. before applying for admission.
- (ii) The candidate appearing in the qualifying examination in the current year can also apply for admission.
- (iii) For M.V.Sc. programme, candidates undergoing internship can also apply. However, they must have completed all the requirements for the award of B.V.Sc. & A.H. degree before registration.
- (iv) Candidates {except NRI/OCI/Government/VCI/ICAR nominee/Postgraduate Diploma Courses/Certificate Courses/ Short Courses} seeking admission to various undergraduate and postgraduate programmes of the university must apply "online" at the university website by the due date and time.
- (v) Only one application is to be submitted for consideration of admission to a particular programme. Submitting more than one application for a particular programme is liable for rejection of candidature.
- (vi) The residents of Punjab or Union Territory of Chandigarh, candidates nominated by VCI and NRI/OCI candidates are eligible for seeking admission to B.V.Sc. & A.H. programme.
- (vii) Counselling/Interview will be as per dates and schedule mentioned in the prospectus and/or notified on the university website. No separate call/invitation letter will be made to the candidate.
- (viii) It is mandatory for a candidate to report personally for counselling/interview as per scheduled date, time and venue, otherwise his/her candidature shall be cancelled and his/her right to admission shall be forfeited.
- (ix) The applicants shall be called for counselling on the basis of merit in descending rank, one after the other. If a candidate called for counselling, does not present him/herself before the committee, his/her claim for any seat shall get forfeited. In case, the candidate reports after his/her name has been called for counselling but within stipulated time on the day of counselling, the seat offered to that candidate shall be out of the seats available at the point of time when he/she reports before the committee.
- (x) If a candidate misses the  $1^{st}$  counselling, he/she can attend the subsequent counselling(s), but he/she will be considered for admission on the basis of merit against the remaining vacant seats only.



- (xi) The special counselling(s) and other update(s) if any, will be notified at the university website. The candidates are advised to visit the university website regularly.
- (xii) The candidates appearing for counselling to UG or PG programme(s) are required to fill the respective admission proforma which will be available at the university website at least one week before the counselling date. The proforma should be downloaded from university website. Duly filled admission proforma along with a set of self-attested copies of all the relevant documents is to be submitted by the candidate at the time of counselling. The candidate must bring original certificates and documents (as per check-list) to be verified by the Counselling Committee, failing which his/her candidature will not be considered for admission.
- (xiii) The candidates who have applied under Sportsperson/NCC Cadet Category (Annexure-A or B) and under Armed Force Category (Annexure IV-A or B) must submit the supporting document(s) up to 24.09.2021 in the office of Director of Students' Welfare-cum-Estate Officer (for Sportspersons and NCC Cadets) and Registrar (for Armed Force Category), failing which, claim for admission under the said category shall stand cancelled.
- (xiv) The prescribed dates will not usually be changed, even if dates are declared as holidays. However, if any change is mandated due to any exigency, it will be notified on the university website (www.gadvasu.in).
- (xv) To avoid any kind of inconvenience or last minute rush and/or any unforeseen difficulties, the candidates are advised to submit application forms without waiting for the last date.
- (xvi) The students admitted to the various academic programmes in the university shall have to abide by all the rules and regulations (as applicable) of the Guru Angad Dev Veterinary and Animal Sciences University, Ludhiana.
- (xvii) The Registrar may, at his discretion, cancel the admission of a candidate if at any time, it is found that the candidate obtained admission by misrepresentation/concealment of facts or the admission was made due to error, oversight, etc.

## **INTRODUCTION**

Guru Angad Dev Veterinary and Animal Sciences University (GADVASU) was established on 9th August, 2005 at Ludhiana (and started functioning from 21st April, 2006) through Punjab Act no. 16 of 2005. Initially, only the College of Veterinary Science (established in 1969), was shifted from Punjab Agricultural University to Guru Angad Dev Veterinary and Animal Sciences University. The university has grown remarkably since its inception and is already amongst the top Veterinary and Agricultural Universities in the country. In order to produce highly efficient and skilled human resource for giving further boost to activities of livestock, dairy and fishery sectors in Punjab, the University has established College of Fisheries, College of Dairy Science and Technology and College of Animal Biotechnology for teaching, research and extension in the respective fields. The above four constituent colleges are at Ludhiana campus. Another constituent College of Veterinary Science was established at Rampura Phul, Bathinda, about 110 kms from Ludhiana. In all the five constituent colleges, English is the medium of instructions.

Regional Research and Training Centres (RRTCs) at Kaljharani (Bathinda), Talwara (Hoshiarpur) and Booh (Tarn Taran) have been established for catering the specific needs of the area. A new RRTC-cum-Multispecialty Veterinary Hospital is coming up at Sapanwali, Abohar (Distt. Fazilka) to cater the South-Western region of the state. Three Krishi Vigyan Kendras (KVKs) have been established at Tarn Taran, Barnala and Mohali districts of Punjab for technology assessment, refinement, demonstration and adoption.

The University has been recognized by the University Grants Commission (UGC) to receive central assistance under section 12(B) of UGC Act, 1956. GADVASU got accreditation from UGC and ICAR and has been admitted as a regular member of the Association of Indian Agricultural Universities (AIAU) and Association of Indian Universities (AIU). Indian Council of Agricultural Research (ICAR) has accredited the university and its four constituent colleges viz. College of Veterinary Science, College of Fisheries, College of Dairy Science and Technology and College of Animal Biotechnology with grade 'A'. The university has a Veterinary Polytechnic college at Kaljharani, Bathinda for the award of two year Diploma in Veterinary Science and Animal Health Technology. A private college, Khalsa College of Veterinary and Animal Sciences, Amritsar and a private polytechnic, Baba Hira Das Ji College of Veterinary Pharmacy, Badal, Sri Muktsar Sahib are affiliated to the university.

- To foster faculty development by providing them opportunities to participate in appropriate training programmes, conferences, workshops, seminars, symposia, etc. and avail opportunities in exchange programmes.
- To provide continuing professional education in veterinary, animal, dairy and fishery sciences.
- To provide consultancy, expert opinion and specialist services to livestock owners, government and other agencies for Livestock Policy Formation.



- To run Multi-Speciality Veterinary Hospital for treatment of animals and to provide clinical training to the students.
- To encourage cooperation and collaboration with other departments, colleges, universities and industries, both at national and international levels.
- To undertake extension education activities to extend the knowledge and technology to the end users, i.e., farmers, government, industry, marketing sector, etc.

#### 1.1 Constituent Colleges

#### (a) College of Veterinary Science, Ludhiana

The College of Veterinary Science was set up in 1969 as a constituent college of the Punjab Agricultural University, Ludhiana. With the formation of new university, it became a part of the Guru Angad Dev Veterinary and Animal Sciences University in 2006. The college has 17 departments with excellent laboratory facilities and infrastructure for undergraduate and postgraduate teaching and research. There is a well-equipped. Multi-speciality Teaching Veterinary Hospital to cater to the needs of large and small animal healthcare. In addition, the college owns a well-established Livestock Farm Complex comprising the elite dairy herd, a poultry farm, a goat farm and a piggery unit. The college has distinction of having three ICAR Centers of Advance Faculty Training in Veterinary Surgery & Radiology, Veterinary Gynaecology & Obstetrics and Veterinary Pathology.

The programme leading to the award of the B.V.Sc. & A.H. degree is designed to equip the graduates with the knowledge and skills essential for a career in Veterinary Science and Animal Husbandry as per VCI norms. The programme is divided into three phases: the pre-clinical phase to provide education in basic aspects such as Veterinary Anatomy, Physiology, Biochemistry, Genetics &





Breeding and Extension through intramural learning. The para-clinical phase includes bridging subjects between the pre-clinical and clinical phases such as Veterinary Pathology, Microbiology, Public Health & Epidemiology, Parasitology, Pharmacology & Toxicology, Nutrition, Livestock Farm Practices and Livestock Products Technology. The clinical phase includes Veterinary Surgery & Radiology, Medicine and Gynaecology & Obstetrics. At the end of the course work, the students undergo a compulsory rotational internship programme of one year in areas of Diagnostic Laboratories, Clinical Practice and Animal Production Technologies.

Successful completion of B.V.Sc. & A.H. programme entitles the graduates to seek mandatory registration with the Punjab State Veterinary Council/Veterinary Council of India as a Registered Veterinary Practitioner. The college is recognized by the Veterinary Council of India (VCI) and all the ongoing UG and PG programmes in the college have been accredited by the Indian Council of Agricultural Research (ICAR) with 'A' grade. #### (b) College of Veterinary Science, Rampura Phul, Bathinda

The College of Veterinary Science, Rampura Phul,



Bathinda was established as a constituent college of Guru Angad Dev Veterinary and Animal Sciences University, Ludhiana. The foundation stone of the college was laid on 30<sup>th</sup> October, 2014. It became functional on October 1, 2019 by admitting 80 students to the B.V.Sc & A.H. programme with the VCI approval. The mandate of the college is to produce veterinary graduates to overcome the deficiency of veterinary professionals in the state. In addition, its endeavor will be to implement the research outputs and extension education programmes for better livestock health and production, especially in the South-Western zone of Punjab. The college campus comprises of college buildings, veterinary hospital, farms, playgrounds and fodder production area. The residential complex comprises of hostels, guest house and staff quarters.



At present, there are 13 departments viz., Veterinary Anatomy, Physiology & Biochemistry, Livestock Production & Management, Microbiology, Pathology, Nutrition, Genetics & Breeding, Public Health & Epidemiology, Livestock Products Technology, Parasitology, Pharmacology & Toxicology, Veterinary Clinical Complex and Livestock Farm Complex, which are fully established and functional with excellent laboratory and infrastructure facilities as per VCI norms. The college offers following academic programmes:

#### (c) College of Fisheries

Since its establishment in 2008, the College of Fisheries has registered a commendable academic growth and has made significant contributions in the development of the fisheries sector in the State. The college has five departments viz., Aquaculture, Fisheries Resource Management, Aquatic Environment, Fish Processing Technology and Fish Engineering. The college has excellent laboratories equipped with modern instruments and facilities. The college owns an Instructional-cum-Experimental Farm for UG and PG teaching, demonstrations and research. This includes nursery ponds, rearing ponds, stocking/production ponds, demonstration ponds, integrated models, modern indoor as well as outdoor hatcheries (for carps, catfish and ornamental fish), aquaponics, poly houses for overwintering of cold sensitive species, aquarium house, aquatic plant rearing unit, feed mill, raceway, etc.



The academic curricula of the UG and PG degree programmes are as per ICAR guidelines. College has been accredited by the ICAR with 'A' grade. The Fisheries professionals have substantial scope of employment in public sector [Fish Farmer's Development Agencies (FFDA), State Agricultural/Veterinary Universities, Agricultural Technology Management Agency (ATMA), Krishi Vigyan Kendras (KVKs), Research Institutes, etc.] and private sector (Hatcheries, Feed industry, Processing industry, Pharmaceutical industry, etc.) across the country, besides substantial scope of self-employment and

#### (d) College of Dairy Science and Technology

College of Dairy Science and Technology was established in the year 2008 as one of the constituent colleges of the university with an undergraduate B.Tech. (Dairy Technology) programme of four years duration. There are five constituent departments of the college i.e. Dairy Technology, Dairy Engineering, Dairy Chemistry, Dairy Microbiology and Dairy Economics & Business Management. The course curricula of UG and PG programmes are as per guidelines of the ICAR. B.Tech. is a unique, skill improving and job oriented degree programme recognized by the Indian Council of Agricultural Research (ICAR). The college was accredited by ICAR with 'A' grade.



Punjab is a one of the leading states in milk production with the highest per capita availability of milk in the country. Looking into the vast scope of milk processing industry in the country and the requirements of manpower for the same, there is immense scope of this programme. Over the years the intake capacity per batch was enhanced from 30 in 2008 to 50 in 2020. More than 80% of the college faculty is Ph.D. degree holder. The faculty has brought laurels to the University by winning research projects, developing new technologies and winning awards at national and international levels. All the departments of the college have well equipped laboratories to meet the requirements for effective teaching of UG and PG programmes. To strengthen the student's skill in milk processing, the college is having a well-established Experimental Dairy Plant with milk handling capacity of about 5000 litres per day. The students undergo an industrial training for one semester in reputed dairy industries across the country. Students are being hired by the industry through on-campus interviews. The alumni of the college are working in various institutes and industries such as MilkFed Punjab, Nestle, AMUL, etc. The students also venture for higher studies in national and international institutes. #### (e) College of Animal Biotechnology

During the last three decades, molecular biology and biotechnology have emerged with extensive applications in animal husbandry, medicine, industry and environmental sciences. Recognizing the immense potential of biotechnology in animal sector, Guru Angad Dev Veterinary and Animal Sciences University established the Department of Animal Biotechnology in 2008. It was designated as School of Animal Biotechnology in 2010 and upgraded to College of Animal Biotechnology in 2019. The mandate of the college is to generate scientific expertise, human resource in various facets of animal biotechnology and to develop





specialized facilities for research in cutting edge fields of biotechnology. The college is also involved in basic and applied research spanning a wide-spectrum of areas like genomics, molecular diagnostics, vaccinology, stem cell biology, cancer biology, proteomics and bioinformatics.

To cater the needs of undergraduate and postgraduate teaching and research, three departments viz., Animal Biotechnology, Microbial & Environmental Biotechnology and Bioinformatics have been created with excellent infrastructure and laboratory facilities. For the UG and PG teaching, the college is following the course curriculum as recommended by the ICAR. The college has been accredited by the ICAR with 'A' grade. A minimum of two years professional experience (after completion of Bachelor's degree) in any department of Punjab Government/Union Territory of Chandigarh/Central or State Government/Semi-Government organizations on the last date of receipt of applications.

(i) The in-service candidate will be considered for admission only if his/her application is duly forwarded through proper channel by the Head/sanctioning authority after certifying that during the study period his/her lien will be retained and on completion of studies, the candidate will join back on the said post.

The minimum eligibility qualification for admission to Ph.D. programmes of the university shall be an OCPA of 7.00/10.00 or 70% marks in aggregate in the Master's degree and OCPA/OGPA of 6.00/10.00 or 60% marks in aggregate in Bachelor's degree from a recognized institute/college/university established by law in India. The eligible Master's and Bachelor's degree for admission to specific Ph.D. programme are as shown against respective discipline in table under Sr. No. 2.5.4.

#### 2.5.5 Ph.D. Programme for in-service candidates

The minimum eligibility qualification for admission to Ph.D. programmes of the university for in-service candidates shall be the same as in case of other than inservice candidates mentioned at Sr. No. 2.5.4 above.

For admission to Ph.D. programme, an in-service candidate must be an employee of a University/ National Institute/Punjab Government/Union Territory of Chandigarh/Central or State Government/Semi-Government organizations having at least two years of experience of Teaching/Research/Extension.

#### Note:

- (i) The in-service candidate will be considered for admission only if his/her application is duly forwarded through proper channel by the Head/sanctioning authority after certifying that during the study period his/her lien will be retained and on completion of studies, the candidate will join back on the said post.
- (ii) The preference for admission under in-service category will be given to the candidates working with Punjab Government/Semi-Government organizations followed by other state candidates.

#### 2.6 Regulations for Admission under NRI/OCI Category

- (i) In NRI/OCI category, the university offers admission to B.V.Sc. & A.H., B. Tech. (Dairy Technology), B.F.Sc., B. Tech. (Biotechnology), Master's and Ph.D. programmes. Only the NRIs/OCI or their children/ wards (as per the judgement of Honorable Supreme Court for Appeal (Civil) 5041 of 2005) are eligible to apply. The interested candidates are required to submit a duly filled application form (format available at university website) along with fee of US\$ 750 or equivalent in Indian rupees (non-refundable) (the bank charges, GST, etc. will be borne by the applicant) and copy of relevant certificates showing grades/marks and conversion formulae for calculating percent equivalent marks.
- (ii) The NRI/OCI candidates seeking admission to undergraduate programmes are not required to appear in NEET (UG) – 2021/JEE (Mains)- 2021 or any other entrance test. However, they must have passed

10+2 standard level examination with minimum of 50% marks in individual subjects of Physics, Chemistry, Biology/Mathematics and English as per eligibility requirement of the programme to be applied for. The eligibility of qualification will be subject to verification of equivalence with the 10+2 examination of recognized Indian Education Board(s), etc. The candidates must furnish the details of subjects studied, grades and percentage equivalent marks in the relevant columns of NRI/OCI Application Form. The syllabus of the courses studied at 10+1 and 10+2 level, contact details and the website address of the institute attended needs to be attached with the application. Mere submitting of the application does not guarantee admission to the programme applied for.

- (iii) The NRI/OCI candidates seeking admission to Master's and Ph.D. programmes must fulfill the eligibility criteria prescribed for Resident Indian students. Their merit will be prepared on the basis of marks of qualifying examination and interview (as applicable).
- (iv) The candidates are also required to submit self-attested photocopies of birth certificate, citizenship/permanent resident certificate and passport or any other valid document justifying their NRI/OCI status, along with the application form. The original documents will be verified at the time of counselling.
- (v) In NRI/OCI admissions, priority will be given to the candidates of Punjab and Union Territory of Chandigarh origin.
- (vi) The selected candidates are required to pay the admission, tuition fee, etc. (as detailed at Sr. No. 5.4 (b) of Chapter V) by online transfer or by Bank Draft in US dollars from the bank account of NRI/OCI in his/her country of residence. The fee can also be paid in equivalent Indian Rupees in the form of Bank Draft issued from the NRE/OCI bank account of candidate/ parent/spouse maintained in India. In the latter case, the candidate is required to submit a certificate from the bank that the draft has been issued against candidate/ parent/spouse NRE/OCI account along with currency equivalence certificate. The bank draft should be drawn in favour of "Comptroller, GADVASU" payable at any



scheduled bank in Ludhiana, India. The hostel dues and other fees and sundry charges as applicable, will be charged in Indian currency, in addition to admission and tuition fee, as per university rules. Foreign Bank Charges/Correspondent Bank Charges will be borne by the student, in addition to fee. The student will also have to pay GST which will be charged by the bank on Foreign Transactions.

(vii) In affiliated Private Veterinary College, the seat(s) remaining vacant/unfilled under NRI/OCI category, if any, shall be converted to Special Management Quota seats. These converted seats will be filled from open merit as per prescribed eligibility criteria.

#### 2.7 Rules and Regulations for Admission to Foreign Nationals

 (i) The foreign national candidates may be considered for admission (in absentia) against additional seats. Their admission will be regulated by the ICAR/ICCR, New Delhi. The foreign students seeking admission must have a valid student visa, declared medically fit (Annexure-F) by the Medical Officer authorized by the Indian Embassy in the home country of the student and must have full medical insurance.

- (ii) The foreign students will be charged an Institutional Economic Fee @ US \$ 2000 per year per student of SAARC country and US \$ 4000 for a student from countries other than SAARC countries and as amended from time to time. The institutional economic fee will be charged for two years in Master's programme and for three years in Ph.D. programme. However, the tuition fee and other charges have to be paid throughout the period, for which a student remains enrolled in the programme.
- (iii) The institutional economic fee may not be charged from the candidates admitted by the Govt. of India under certain fellowship/scholarship such as Nepal Aid Fund, Colombo Plan, Indian Technical and Economic Cooperation Programme, General Cultural Scholarship and Cultural Technical Exchange as per specific provisions of the scholarship/fellowship.
- (iv) Tuition fee and other charges will be applicable as per instructions issued by the university from time to time.

Further, a category-wise merit list of the applicants based on 10+2 marks for B.F.Sc., B.Tech. (Dairy Technology) and B.Tech. (Biotechnology) programmes will be prepared. The programme wise merit list of the applicants will be displayed on the university website (www.gadvasu.in) before the date of 1<sup>st</sup> counselling. The candidates seeking admission to various programmes of the university must attend the counselling as per schedule to be displayed on the university website.

#### Note for all the candidates of UG & PG Programmes:

(i) The status of vacant seats, if any, will be available on the university website at least one day prior to the  $2^{nd}/3^{rd}$  Counselling/Interview. The date of special counselling(s), if any, will be notified on the University website. The candidates are advised to visit the university website regularly for any updates.

 (ii) If a candidate misses the 1<sup>st</sup> counselling, he/she can attend the subsequent counselling(s), but he/she will be considered for admission on the basis of merit against the remaining vacant seats only.



- (iii) No separate intimation will be sent for counselling. For consideration of admission, the candidate must be physically present at counselling as per schedule. Absentees, for any reason whatsoever, will not be considered for admission.
- (iv) There are separate "Admission Forms" for admission to UG and PG programmes, which will be available on the university website at least one week before 1<sup>st</sup> counselling. The duly filled Admission form along with self-attested copies of all the relevant documents (as per checklist at Sr. No. 3.3) must be submitted by the candidate at the time of counselling. All the original certificates/documents are required to be submitted/shown to the Counselling Committee, failing which the candidate will not be considered for admission.
- (v) The university will not pay any T.A./D.A./or any other expenses for appearing in the counselling/ interview.
- (vi) Date of counselling/interview will not usually be changed even if the university is closed on that day on any account, except severe natural calamities/ unforeseen circumstances
- (vii) During counselling, the candidates will be called in the descending order of merit prepared by the university as per prescribed criteria.
- (viii) At the time of counselling/interview, the Selection Committee shall also consider the past record of the candidate. If, it is known that the candidate has been involved in any act of indiscipline in the hostel/ college/school/institute or in organizing unlawful demonstrations, etc., the Selection Committee may refuse admission to such candidates. The candidate, who has been expelled/rusticated or debarred by any university/institute, shall not be admitted. Hiding of facts whatsoever may attract disqualification of a candidate, if it so warrants, as and when such facts come to notice of the university.
- (ix) The selected candidates shall have to deposit the fee immediately after counselling agreeing to the terms and conditions detailed in Chapter V. The selection notice will be issued only after the deposit of full fee by the candidate as per prescribed procedure.
- (x) No admission in undergraduate and postgraduate programmes shall be made after the last date of admission, unless date(s) for special counselling(s) is/are notified by the university on the website.
- (xi) The selected candidates are required to submit the medical fitness certificate to be obtained from the University Medical Officer. The medical examination

fee of Rs. 390/- will be charged by the University Health Centre. Any candidate found medically unfit, shall be entitled to refund of admission fees. In such cases the application for refund must be submitted within 14 days from the issue of selection notice.

(xii) In case of Master's and Ph.D. programmes, the seats remaining vacant during the 1<sup>st</sup> semester may be filled in the next semester.

- (ii) NRI/OCI seats (additional): Maximum of two seats in Master's programme and maximum of one seat in Ph.D. programme may be filled in each discipline under NRI/OCI category.
- (iii) Additional seats, 2% or at least one seat each in B.V.Sc. & A.H., B.F.Sc., B. Tech. (Dairy Technology) and B.Tech. (Biotechnology) programmes (over and above existing seats) only in constituent colleges of the university are reserved under Employees Ward Quota for the wards of permanent employees (including those on probation) of GADVASU and currently

in service/retirees/deceased provided the candidate fulfils the minimum eligibility requirements as of General Category candidates based on merit. However, no fee concession will be granted to the candidates securing admission under this category.

- (iv) In Master's programme, maximum of two additional seats and in Ph.D. programme maximum of one seat may be filled in each discipline under Self-financed category in College of Veterinary Science, Ludhiana.
- (v) There will be two additional seats in M.Tech.
   (DT) and one seat each in other disciplines of the Master's programme of College of Dairy Science and Technology, Ludhiana under Self-financed category.
- (vi) There will be one additional seat under self-financed category in each Master's discipline in College of Fisheries and College of Animal Biotechnology.
- (vii) One additional seat for Kashmiri migrants in each undergraduate and postgraduate programmes of constituent colleges.
- (viii) In Master's programme, one additional seat under Kashmiri Migrant category may be allotted as per the choice of the candidate. However, the same subject



where the students have opted earlier in Kashmiri Migrant category, shall be allowed only after a gap of three years.

- (ix) One additional seat under Sportspersons/NCC Cadets category is reserved in Master's programme of College of Veterinary Science, Ludhiana as mentioned at Sr. No. 4.1.2(1). This seat may be allotted as per choice of the candidate. However, the same subject where the students have opted earlier in Sportspersons/NCC Cadets category, shall be allowed only after a gap of three years. Other rules and guidelines as mentioned elsewhere in the prospectus will remain the same.
- (x) In Master's programmes, not more than one candidate, out of the Sportspersons/NCC Cadets and Kashmiri migrants will be admitted in any one discipline as per the merit list among these categories of eligible candidates. However, preference will be given to Sportspersons/NCC Cadets category.
- (xi) In postgraduate (Master's and Ph.D.) programmes, one additional seat in each discipline may be filled under in-service category.

#### Note 2:

- (i) All the programmes of the university are full time residential programmes except specific PG Diploma, Certificate and Short courses. A student, therefore, cannot be admitted to more than one programme at a time in this or any other university.
- (ii) Admission to all the programmes except PG Diploma, Certificate and Short Courses in the university is made by the Registrar on the recommendation of the Counselling/Selection Committee.

(iii) The admission obtained by a candidate due to misrepresentation/concealment of facts or admission made due to error/oversight at university level, can be cancelled at any stage.

PROSPECTUS 2021-22

- (iv) Any seat remaining vacant in B.F.Sc., B.Tech. (Dairy Technology) and B.Tech. (Biotechnology) under the Self-financed category will be filled from open merit candidates. Thereafter, any remaining vacant seat may be filled from candidates from other states.
- (v) Seats remaining vacant under 'Other States' category will be converted into general category for filling on merit from all other eligible candidates.
- (vi) The seats meant for resident Indians (all categories) in KCVAS will be filled strictly on Merit based on NEET (UG) - 2021 rank/score, and those for NRI/ OCI as per guidelines laid down by GADVASU in Chapter II, S. No. 2.6.
- (vii) In KCVAS, the seats remaining vacant from VCI quota will be filled up under the University quota, and the seats remaining vacant from NRI/OCI quota will be filled up under Special Management quota.
- (viii) The fee structure and number of seats in any programme and category can be changed by the competent authority without any notice.
- (ix) The Academic Council of the University is the supreme authority to frame rules and regulations, and to decide all other matters relating to admissions and academic affairs. The Academic Council also has the right to promote or discontinue any programme and also to increase or decrease seats in any programme, whatsoever.

#### Note for KCVAS:

- (i) The fee will be payable on a yearly basis and the college shall not insist on the candidate to deposit the fee for the entire course in advance. At the most candidates can be asked to furnish a surety bond/bank guarantee that they will be liable to pay the balance fee for the whole course even if they leave the degree program in-between.
- (ii) In case of a candidate is shifted from one quota to another (e.g. Special Management/University Quota) within the college in the subsequent counselling(s) on movement of merit, the college shall adjust/refund the fees to the concerned students within 15 days, as per university rules.
- (iii) The university will charge an examination fee of Rs.9100/- per annum from every student of the college as per University rules. In the event of compartment, a fee of Rs.4850/- shall be charged per paper per student.
- (iv) The college will charge the same fees from the students eligible for Post-Matric Scholarship Scheme admitted under SC/ST Category (University Quota) as is being charged by the GADVASU.
- (v) The fee for 4<sup>th</sup> professional in B.V.Sc & A.H programme, which is comprised of 1<sup>1</sup>/<sub>2</sub> years, will be collected in two instalments: one year fee at the time of registration of 4<sup>th</sup> professional year and remaining six months fee after completion of one year.



#### Note: Applicable to all the programmes and all the categories of students

- (i) The University reserves the right to enhance the fees, charges, funds, etc. at any time. An Annual incremental increase of 10% in the fee structure shall be applicable to the constituent and affiliated colleges of the university, excluding tuition fee of Self-financed/Category-II seats of constituent colleges and Management/Special Management quota seats of affiliated private college. However, there will be no increase in tuition fee for the students of M.Sc. (Biotechnology) with specialization in Animal Biotechnology under DBT-Postgraduate teaching programme admitted through GAT-B.
- (ii) In case of hosteller students, the electricity bills received in excess of the electricity fund collections, shall be

proportionately charged from the residents of the respective hostels.

- (iii) The securities not claimed for three semesters succeeding the semester in which the student leaves the college either by completing a particular degree programme or dropouts/otherwise, shall be forfeited. In case of interns, claims for refund of hostel security shall be entertained after the completion of the internship programme.
- (iv) All claims for refund of hostel security shall be entertained through the concerned college.
- (v) Hostel accommodation shall be provided subject to availability only.



# CHAPTER VI

### **REGULATIONS REGARDING RUSTICATION AND EXPULSION OF STUDENTS**

- The Dean/Principal of the college shall have the power to expel or rusticate a student for sufficient reasons, including acts of indiscipline and misconduct inside or outside the college.
- Case(s) of rustication or expulsion of the student shall be immediately reported by the concerned Dean/Principal to the Registrar for registration and notification.
- 3. The Dean/Principal may revise his/her decision within 15 days of passing the order of rustication or expulsion. The revised decision composed with reasons shall be communicated to the Registrar for placing before the Academic Council.
- 4. The period of expulsion/rustication shall be minimum of two semesters/one academic year to maximum of four semesters/two academic years.
- 5. The student under rustication shall have the option of rejoining the class during the ensuing semester after the expiry of the period of rustication.
- 6. It shall be obligatory for the college to re-admit a rusticated student if he/she wishes to rejoin after the expiry of the rustication period.
- 7. The name of the rusticated student shall not be maintained on the rolls of the college and the student will not be charged any fee during the period of rustication.
- 8. A student expelled from the college shall not be allowed to seek fresh admission into the same or another college of the university without the sanction of the Academic Council. In no case, such a student shall be allowed to do so before the expiry of two academic years, excluding the academic year in which he/she was expelled.

9. Any fact that makes the Vice-Chancellor consider that the order passed by the Dean/Principal requires revision, the Vice-Chancellor may bring the case to the notice of the Academic Council, after consideration of the matter, the decision of the Academic Council shall be final.

#### 10. Instructions/Regulations Regarding Anti-Ragging

"Ragging" is strictly prohibited in the colleges as well as in the hostels. Any student found indulging in the act of ragging will be strictly dealt with according to the directions given by the Hon'ble Supreme Court of India. According to Raghavan Committee observations, ragging has several aspects including psychological, social, political, economic, cultural and academic dimensions. The anti-ragging committees and squads have been constituted at the college level to keep a check on the incidents of ragging. If found guilty, it may invite punishment up to the expulsion of the guilty student from the institute or registration of F.I.R. under provisions of the Indian Penal Code. Every student and his/her parents/guardian are supposed to submit an following affidavits that the student will desist from ragging in any form:

- An annual undertaking to be signed by each student whether fresher or senior, and his/her parent(s) jointly stating that each of them have read the relevant instructions/regulations against ragging as well as punishments, and that if the ward has been found guilty, he/she should be proceeded against (Annexure XI-A, B).
- Undertaking should be provided in English as well as in the vernacular language (Annexure XI-A, B).





### **REGULATIONS REGARDING R & V Sqn. NCC, CCA, NSO AND NSS**

### 7.1 Regulations Regarding R & V Sqn. NCC/NSS for B.V.Sc. & A.H. programme

- The students (except NRI/OCI/Foreign Nationals) admitted to B.V.Sc. & A.H. programme have to register for compulsory R & V Sqn. NCC course at COVS, Ludhiana and compulsory NSS course at COVS, Rampura Phul, each of 0+1 non-credit for the first three years (NCC/NSS I, II & III). The NRIs/OCI/Foreign Nationals are exempted from this programme, but they have to enroll for other Cocurricular activities (CCA) for three years.
- 2. A student may be exempted from registering this course on medical grounds by the Vice-Chancellor on the recommendation of the Dean of the college. In such cases, the student has to produce the medical certificate from the university Medical Officer and consent letter from the NCC Officer.
- 3. The performance of the students in the course will be evaluated on the basis of the examination conducted at the end of each academic year. A 75% attendance in parades/course is mandatory; failure to do so will make the student ineligible to appear in the annual examination.
- 4. The students will be awarded with the Satisfactory (S)/ Unsatisfactory (US) grade.
- 5. If a student obtains 'US' grade in a group, he/she shall have to register for the same group of R & V NCC courses in the subsequent year. However, a student cannot register simultaneously for more than one group. If the student obtains 'US' grade at the end of 3rd year, he/she shall have to register for making up R & V Sqn. NCC deficiency in the 4<sup>th</sup> academic year in addition to regular courses.
- 6. It is mandatory for every student to attend one annual training camp in the 2<sup>nd</sup> year of B.V.Sc. & A.H. as a part of the degree requirement.
- 7. A student on successful completion of Group-I, Group-II and Group-III R & V Sqn. NCC courses and

attending one annual training camp may be relieved from R & V Sqn. NCC, and he/she will be eligible to start his/her internship programme.

- In case, due to some emergency, the R & V Sqn. NCC authorities are not able to arrange the compulsory annual training camp; the Vice-Chancellor may relax such regulations concerning the annual training camp, as it can not be completed.
- 9. The Dean, College of Veterinary Science shall be the Overall in-charge for this programme.
- 10. The B.V.Sc. & A.H. students opting for the NSS programme will be governed by the rules mentioned at 7.2.2.

#### 7.2 Regulations Regarding NSO, NSS and CCA

The students admitted in B.F.Sc., B.Tech. (Dairy Technology) and B.Tech. (Biotechnology) are required to participate in any one of the NSO, NSS and CCA programmes during the first and second year of the degree programme (as applicable). It is specified that the NSO will be assigned to only those students who show marked proficiency in sports. The programme of NSO shall be optional for the students other than in the first and second year. The foreign nationals are exempted from NCC/ NSO/NSS and shall have to register for CCA. Immediately after admission, the concerned Dean/Director Students' Welfare-cum- Estate Officer shall enroll the students under the particular programme and submit the list to the Registrar for completing the personal files of the students. The students enrolled in a scheme, shall not ordinarily be allowed to change it afterwards.

#### 7.2.1 NSO

- 1. Undergraduate students who register for NSO, shall complete the requirements in the first four semesters of their studies.
- The students opting for NSO training shall have to devote 150 hours of actual play in a year. Failure to attend 75% training period during a semester will



lead to award of 'US' grade to the student. If a student fails to obtain 'S' grade at the end of second/fourth semester, he/she shall have to register for subsequent semester for making up deficiency of NSO training only, in addition to regular courses in the next semester.

- 3. Attendance of 75% training period in a semester/ year is compulsory. The Vice-Chancellor may grant exemption in NSO to a student on medical grounds on the production of a medical certificate from the University Medical Officer and recommendation by the Director Students' Welfare-cum-Estate Officer.
- 4. It is mandatory for the students undergoing NSO training to attend one training camp of 20 days within the first four semesters of training failing which he/she has to register for the next semester to enable him/her to make-up for the deficiency of the camp.
- 5. A student who has undergone NSO training in some other college/institute for a complete academic year, may be exempted from NSO training for the period already completed by him/her, by the Director Students' Welfare-cum-Estate Officer.
- 6. If a student becomes physically unfit for NSO training on medical grounds or due to accident or is dropped for any reason, the Director Students' Welfarecum-Estate Officer may temporarily exempt such a student and he/she has to complete the training in the subsequent semester.

### 7.2.2 NSS

- The enrolled students are required to attend the NSS for the first four semesters of their studies. However, for B.V.Sc. & A.H. programme students it will be for 3 years.
- 2. The student is required to put in a minimum of 120 hours per year in NSS. Failure to do so shall earn the student 'US' grade followed by a warning to make-up for the deficiency in the following semester/year. If a student fails to complete the deficiency and is awarded 'US' grade in 2<sup>nd</sup>/4<sup>th</sup> semester, he/she shall have to register for the 3<sup>rd</sup>/5<sup>th</sup> semester for making up for NSS deficiency, in addition to regular courses.

- 3. The Vice-Chancellor may exempt any student from NSS, on medical grounds on the production of a medical certificate from the University Medical Officer and recommendation of the Director Students' Welfare-cum-Estate Officer.
- 4. Aside from putting regular 120 hours in NSS, each student is required to attend two 7-10 days Special Camps. A day at camp is calculated as 7 hours of service. In case of failure to attend the camp, the student has to register for NSS in the next semester/ year to make-up for the deficiency of NSS camp, in addition to regular courses.
- 5. A student who has undergone NSS training in some other College/Institute for a complete academic year may be exempted from NSS training for the period already completed by him/her, by the Director Student's Welfare-cum-Estate Officer.

### 7.2.3 CCA

- NRIs, OCIs and Foreign National students have to enroll for a course of Co-Curricular Activities (CCA) of 0+1 (NC) for two/three years, as applicable.
- 2. In the CCA programme, the classes will be held for forty hours a semester or eighty hours a year for the two/ three years, as applicable.
- 3. A student enrolled under the CCA programme must attend a minimum of 75% classes held in a year. On failure to do so, the student will be awarded US grade and given a warning to make up for the deficiency in the following year. If he/she fails to complete the deficiency and is awarded US grade in the third year, he/she shall have to register for the same group for the purpose of making up for CCA deficiency in the next semester/year, in addition to regular courses.
- 4. A student may be exempted from CCA on medical grounds by the Vice-Chancellor, on the production of a medical certificate from the University Medical Officer and recommendation by the Director Students' Welfare-cum-Estate Officer.
- 5. The students undergoing CCA training are required to attend one annual training camp during the first two years of training.



# CHAPTER VIII

### SCHOLARSHIPS, STIPEND, FELLOWSHIPS, AWARDS, MERIT CERTIFICATES AND MEDALS

#### 8.1 Scholarships

#### (a) University Scholarship

This scholarship, valued at Rs. 500/- per month, is awarded to the meritorious students of undergraduate programmes on the basis of score/rank/marks obtained in the qualifying test/examination merit list for admission. The number of scholarships is determined college wise by the academic council from time to time.

#### (b) National Talent Scholarship (NTS)

The ICAR/VCI awards merit scholarships in undergraduate and postgraduate programmes for the full duration of the degree programme subject to fulfillment of prescribed conditions. The value of scholarship is Rs. 3000/- per month for UG student and Rs. 5000/- per month for PG student.

#### (c) Post Matric Scholarship (PMS) Scheme

The Government sponsored scheme of Post Matric Scholarships to the students belonging to scheduled castes is applicable as per the guidelines/instructions of Government. Students availing Post Matric Scholarship scheme will have to repay the amount as soon as the amount comes in his/her account by direct beneficiary transfer. The detailed guidelines of the scheme are available on the university website.

#### (d) Dr. G. S. Khush Scholarship

Two scholarships each for the students of B.V.Sc. & A.H. and B.Tech. (Dairy Tech.); and one scholarship for students of B.F.Sc. will be awarded by Dr. G. S. Khush Foundation for Agriculture Sciences @ Rs.1200/- per month. The scholarship will be awarded to the students from rural background only, on the basis of merit of NEET (UG)/JEE (Mains)/10+2 examination (as applicable) in first professional year and on the basis of OGPA/OCPA of the previous year for subsequent years.

#### (e) Sports Scholarship

The university awards the sports scholarship @ Rs. 350/- per month on fulfillment of prescribed conditions. The number of scholarships are four for major games (viz., Hockey, Football, Athletics and Cricket) and four for the minor games.

### (f) DBT- Postgraduate Teaching Programme Scholarship

Each student admitted in M.Sc. (Biotechnology) with specialization in Animal Biotechnology will be awarded Rs 5000/- per month as per the terms and conditions of DBT.

#### (g) Sh. Lilakrishan Jhangi Ram Galhotra Scholarship

Scholarship of Rs 2000/- per month will be awarded to the student of B.V.Sc. & A.H. programme of College of Veterinary Sciences, Ludhiana, who secures admission to M.V.Sc. programme at GADVASU, Ludhiana and has scored highest OGPA without failure.

#### 8.2 Stipend

The students enrolled for Ph.D. programme and not in receipt of any fellowship, etc. shall be awarded a stipend of Rs. 750/- per month on fulfillment of the prescribed conditions.

#### 8.3 Fellowships

#### (a) University Merit Fellowship

The University offers fellowships to postgraduate students. The value and number of fellowships for each department is determined by the Academic Council/Board of Management. Currently, the value of each fellowship is Rs. 3000/- per month in Master's programmes and Rs. 5000/- per month in Ph.D. programmes of the university. One fellowship is awarded for every 7 students or a part thereof in each department in Master's programmes, and one fellowship in each class/discipline for every 7 students or a part thereof in each department in Ph.D. programmes.



### (b) Sri Guru Amar Das Ji Fellowship

This fellowship will be awarded @ Rs. 1000/- per month to one M.V.Sc. student on merit basis, from any discipline of Veterinary College, who has obtained the highest OCPA in B.V.Sc. & A.H. amongst the eligible applicants for this fellowship and whose family income does not exceed Rs. 6.0 lakhs per annum. The fellowship will start from the commencement of M.V.Sc. degree and will be awarded till two academic years in which the student has enrolled.

### (c) Dr. Jugraj Singh Dhillon Fellowship

One fellowship @ Rs. 3000/- per month will be awarded on merit basis to a M.V.Sc. student majoring in the discipline of Animal Genetics and Breeding.

### 8.4 Awards

### (a) Mata Ind Kaur Award

A cash award up to a maximum of Rs. 10,000/- per annum will be awarded to three meritorious B.F.Sc. students who have achieved maximum OCPA, but not less than 7.00 out of 10.00, at the end of 1st, 2nd and 3rd year of the degree programme and who are not in receipt of any other fellowship.

### Note for all Scholarships/Fellowships:

Each student can avail only one fellowship/scholarship irrespective of his/her eligibility. The eligibility for the fellowship/scholarship will be determined considering the detailed guidelines for institution of the specific fellowship/ scholarship.

### 8.5 Merit Certificates

Merit Certificates are awarded to the students who achieve an OCPA/OGPA of 8.00 or more out of 10.00 at the end of their Bachelor's or Master's Degree Programme.

### 8.6 Gold Medals and Medals

The Gold Medals are conferred at the time of Convocation/Annual Function as under:

### A. Undergraduate Programmes

### 1. College Gold Medals

The college level Gold Medal is awarded to a student securing highest OCPA/OGPA (but not less than 8.00 out

of 10.00) in the class in the programmes of constituent colleges.

- (i) B.V.Sc. & A.H.
- (ii) B.F.Sc.
- (iii) B.Tech. (Dairy Technology)
- (iv) B.Tech. (Biotechnology)

### 2. Dr. Balwant Singh Gold Medal

The Medal is awarded to an all-round best graduate student from all the constituent and affiliated colleges of the university.

### 3. Dr. Kulbir Singh Sandhu Meritorious Medal

The medal will be awarded to an Overall Outstanding Fisheries Graduate (B.F.Sc.) in the college of Fisheries, GADVASU, Ludhiana.

### **B.** Postgraduate Programmes

### 1. Dr. S. C. Dutt Gold Medal

The Medal is awarded to a student who secures the highest OGPA (but not less than 8.00 out of 10) in the class in M.V.Sc. programmes of College of Veterinary Sciences in a given academic session.

### 2. Dr. G.S. Sidhu Medal

The Medal is awarded to the student for excellence in Master's programme in the discipline of Animal Nutrition.

### 3. Dr. S.S. Dhillon Gold Medal

The Medal is awarded to a student for excellence in M.V.Sc. programme in the discipline of Veterinary Microbiology.

### 4. Dr. R.D. Sharma Gold Medal

The Medal is awarded to a student for overall best work in M.V.Sc. programme in the clinical disciplines of Veterinary Gynaecology & Obstetrics, Veterinary Surgery & Radiology and Veterinary Medicine.

### 5. Bibi Amar Kaur Kang Gold Medal

The Medal is awarded to a student for excellence in Master's Programme in the College of Dairy Science and Technology.

### 6. Simrat Sagar Singh Gold Medal

The Medal is awarded to a student for excellence in M.V.Sc. programme in the discipline of Veterinary Surgery & Radiology.

### ANNEXURE – A

#### **CRITERIA FOR ADMISSION OF OUTSTANDING SPORTSPERSONS & NCC CADETS**

#### A. Undergraduate Programmes

- 1. The candidates applying for admission to undergraduate programmes under sportsperson category shall have to obtain a gradation certificate from the Sports Department, Government of Punjab for their performance at 10+1 and 10+2 level in sports as specified in Annexure D. No weightage for sports will be given to the candidates who have participated after 10+2 level. Only the participation in the academic year of passing 10+2 and the preceding year will be considered.
- 2. The candidates admitted to B.V.Sc. & A.H. programme under the sports person category shall attend the play-field during hours other than those scheduled for compulsory R & V Sqn. N.C.C. However, participation in inter-class, inter-college, inter-varsity, State and National tournaments shall be governed by rules as applicable to other academic and co-curricular activities.

#### **B.** Postgraduate Programmes

#### (a) Outstanding Sportspersons

- 1. The order of preference in the selection of outstanding sportspersons for admission to the postgraduate programmes shall be made as per Annexure- B (i). For example, the candidate qualifying for grade 'O' shall be placed at higher merit than the candidate qualifying for grade 'A' followed by grade B and so on.
- 2. In case of individual sports discipline, position of the candidate in an individual event shall be considered and not the position of the team as a whole.
- 3. The candidate should have participated at least twice in the University Inter-College Tournament and once in the All India Inter-Varsity/North Zone Inter-Varsity Tournament/All India Inter-Agricultural University sports and games meet to be eligible for admission under sports category.

#### (b) NCC Cadets

The order of preference in the selection of NCC cadets for admission to the postgraduate programmes shall be made as per Annexure- B (ii). For example, the candidate qualifying for grade 'O' shall be placed at higher merit than the candidate qualifying for grade 'A' followed by grade B and so on.

#### Note (UG and PG programmes):

- (i) For admission under the Sportspersons/NCC Cadets category, a provisional merit list of eligible candidates will be prepared by the Sports Committee constituted by the DSW-cum- Estate Officer. The shortlisted Sportspersons in order of merit, three times the number of available seats, will have to undergo trials for satisfactory performance. The trials will be videographed, and obtaining a satisfactory grading in the trials will be mandatory for admission under sports quota.
- (ii) Only those games/disciplines will be considered for admission under sports category, which are listed in Annexure- D.
- (iii) The candidate seeking admission under Sportspersons/ NCC Cadets category shall be required to submit self-declaration (Annexure-C) regarding his/her achievements in sports. If the candidate is a minor, declaration has to be made by the parents/guardian in respect of child's/ward's achievements in sports.
- (iv) The admission of the candidate under the Sportspersons/ NCC Cadets category shall be made on the explicit understanding that after joining the university, he or she shall attend the play fields regularly and shall also participate in various tournaments. If the candidates fail to do so, his/her admission may be cancelled.
- (v) In case of two or more candidates are obtaining similar grades in Sportspersons/NCC Cadets category, the following criteria will be used to determine the merit of selection for admission under Sportspersons/NCC Cadets category:
  - (a) The candidate winning the higher position in a competition of the same level will be placed higher followed by
  - (b) The candidate representing the competitions at the same level more times followed by
  - (c) The candidate having higher rank/marks in qualifying test/examination as applicable followed by
  - (d) The candidate senior in age

- For winning any of the first three positions in Zonal Inter-varsity/All India Inter-Agricultural University Sports & Games Meet by representing GADVASU Teams.
- 4. For winning any of the first three positions in Zonal

Inter-varsity/All India Inter-Agricultural University Sports & Games Meet by representing Universities other than GADVASU.

The matter has been reconsidered in the light of judgement delivered by Hon'ble Supreme Court of India in the case of Dr. Pardeep Jain vs. Union of India and others reported as AIR 1984-SC-1421 wherein it was held that instead of the word 'Domicile' the word 'Residence' be used in the instructions issued by the State Governments on the subject. 

- 7. **Upload section:** This section contains the provision to upload the images required for filling the online application. You need to have the scanned copy each of your latest passport sized photograph showing full face, signature and left hand thumb impression in case of male and right hand thumb impression in case of female candidates (preferably jpg format). Image should be less than 50 kb each. The photograph with goggles/coloured glasses/cap, etc. is not allowed. The candidate should secure 4 copies of the same passport sized photograph that has been uploaded. These will be required at the time of counselling.
- 8. **Present Address:** Enter the complete address and ensure that no part of the address is missing. Enter a valid PIN code.
