### INTRODUCTION

#### **BRIEF HISTORY:**

The University was established at Faridkot under an Act of Punjab State Legislature (Punjab Act No. 18 of 1998) in the name of great Sufi Saint Sheikh Farid Ganj-E-Shakar, (1173-1265 A.D.) in 1998 for purposes of affiliating, teaching and ensuring proper and systematic instruction, training and research in Modern Systems of Medicine and Indian Systems of Medicine. It is not only affiliating and examining body but also a teaching and research centre in health sciences. It is expected to play a vital role in improving the standards of medical and health education in the state and in conducting relevant research in all aspects of health sciences, basic as well as applied, which ultimately will ameliorate the health standards of the people of Punjab. It is believed that the university will be a trend setter in developing appropriate modes and models of health care to ensure quality health care to the people.

The University has been recognized by MCI vide letter no. V/11015/3/2000-ME (UG) dated 9<sup>th</sup> June, 2000. The UGC has also included the University in the list of recognized universities maintained by the University Grants Commission, under section 2(1) of the UGC Act. 1956 vide letter no. F.9-3/97 (CPP-I) dated 4 July. 2002. The Regional Director. World Health Organization, Regional Office for South-East Asia, World Health House, New Delhi has also forwarded the name of the University for inclusion in the World Directory of Medical Schools vide letter No. M12/6212 dated 6 May 2002. The University is also included in the list of Commonwealth Universities and their yearbook 2001 at page No. 692 (Vol. I).

Established with a mission to create an intellectual, academic and physical environment conducive to free flow of ideas and exchange of information between various faculties of The University, between this University and other Universities of Health Sciences in the country and abroad, thereby opening a window to the world for the health professionals, health planners, health managers, biomedical and social scientists and educationalists in health sciences of the country. Efforts are on to establish contact with various institutions towards achieving this goal.

### **UNIVERSITY'S PRESENT STATUS:**

All the new buildings of the University and its constituent college, GGS Medical College & Hospital were completed in the year 2011. The University was shifted to its new building situated at Sadiq Road, Faridkot in July 2011. Hon'ble Chief Minister, Punjab inaugurated two new University buildings (Senate Block and Academic Block) on 22-09-2011. Hon'ble Deputy Chief Minister inaugurated the Radiotherapy Unit, and other buildings of GGS Medical College & Hospital, on 23-09-2011. The GGS Medical College & Hospital, a constituent college of the University is also shifted to its new building.

The University Campus comprises of GGS Medical College along with Auditorium of 800 capacity, Senate Block, Academic Block, University College of Physiotherapy, University College of Nursing, Drug De-addiction Centre, Telemedicine, Edusat and a well equipped state-of-the-art 500 bedded hospital. Coveted projects to set up Trauma Centre, Regional Cancer Centre all in process. The University has added to its academic convoy University Library & Informatics Division, Department of Health Sciences Library & Information System, University Centre of Excellence in Research, Rose Garden and Herbal Garden.

Recently, Govt. of Punjab has transferred 100 bedded Civil Hospital, Badal to University for strengthening and expanding the connection between rural medical services and the education and research carried on by the Baba Farid University of Health Sciences. The GGS Medical College & Hospital, a constituent college of the University has 24 departments and 21 post graduate departments.

Guru Gobind Singh Medical College & 700 bedded Hospital. Faridkot vide notification no. 8/02/2005-1HB-I11/6308 dated 31.10.2006 and State Institute of Nursing & Paramedical Sciences, Badal vide notification no. 1/46/07-1HBIV/1163 dated 28.11.2007. In addition to above, the Board of Management of University also accepted the proposal for starting of Physiotherapy College in the University campus in its meeting held on dated 03.04.2007 and fourth constituent college was established viz. University College of Physiotherapy. University has also established its own Institute of Pharmacy. The GGS Medical College & Hospital, constituent college of the University has 24 departments and 21 post graduate departments and is recognized by MCI.

### **COLLEGES AFFILIATED WITH UNIVERSITY:**

At present the University is having 150 affiliated colleges comprising 140 affiliated and 10 constituent Colleges (with an approximately 35,000 students).

University will soon endeavor to achieve excellence in health care delivery and Medical Education and Research in the State. Admissions to various undergraduate and post graduate courses in the affiliated institutions of this University in the State of Punjab are made on merit basis through the conduct of Entrance Tests.

The University is now primarily focusing on strengthening postgraduate medical education and research and evolving as a centre of excellence in a rural backdrop.

Selection of the candidates to any institution shall be made on merit and in transparent manner as per Punjab Government Notification/s.

### **College Inspections:**

The University has started conducting the surprise inspections of all the colleges and due to this, the colleges are compelled to maintain their standard related to academic staff, discipline and availability of amenities etc. Moreover, the University has started highlighting the shortcomings which the colleges have failed to rectify. This information is made available to the prospective students at the time of admission, before they select the college of their choice.

### **University Examination System:**

The University had introduced Onscreen Marking Solution and w.e.f. session 2016 and etransfer system of question papers of various courses to the examination centers to maintain the sanctity of examinations. This process and implementation strategies will help us to deliver, efficiency, reliability in high stakes examination and their certifications.

### **PART-A**

### **GENERAL INSTRUCTIONS (PLEASE READ IN DETAIL)**

- 1. This prospectus is divided into 3 parts:
  - Part-A Pertains to the general procedure for applying to admission, submission of admission application/counseling form, deposition of fee, important instructions, joining, etc and demonstration of steps for applying online application form and filling online choices/preference of course/college/quota during online counseling.
  - Part-B Pertains to Punjab Govt. Notifications/corrigendum issued from time to time for admission to MBBS/BDS Courses.
  - Part-C Annexures/specimens of various categories, self declarations and other Notifications issued by Govt. of India/ Govt. of Punjab
- 2. Candidates must strictly follow the instructions laid out in the Prospectus and University website. Candidates not complying with the instructions shall be disqualified.
- 3. This prospectus is subject to alteration(s) / modification(s) at any time without notice. Please visit University website from time to time. Admissions including Eligibility to MBBS/BDS Courses shall be governed and regulated as per the rules and regulations etc, as per Punjab Govt. notifications.
- 4. Instructions in this prospectus are liable to change based on decision(s) taken by the Punjab Government/University from time to time. There is no equity or any rights that are/or deemed to be arising in favour of candidate.
- 5. The candidate should read the eligibility condition carefully. Mere submission of application for admission/counseling does not entitle him/her for admission. Eligibility conditions for admissions are given in the Notification. The eligibility shall be determined by the Selection Committee/Principal of concerned college at the time of counseling/admission. Those who are not eligible as per Punjab Govt. notification will not be considered for admission. Eligibility is also subject to medical fitness and such criteria as may be prescribed by the Punjab Government/ University/Medical institutions/ National Medical Commission/Dental Council of India.
- 6. Candidate's eligibility is purely provisional & subject to the fulfillment of eligibility criteria as Punjab Government Notification incorporated in this prospectus.
- Applications of candidates producing false or fabricated information shall not be considered and candidates shall be further debarred from participating in any future counseling to be conducted by BFUHS, Faridkot.
- 8. Any attempt by a candidate to influence directly or indirectly any person concerned with the admission process will lead to disqualification of the candidate.
- 9. Distribution of seats will be as per Punjab Govt. Notification, the list of eligible colleges/seats may increase/decrease, subject to the orders of Hon'ble Courts/NMC/DCI/Govt. The final position of seats will be displayed at the time of counselling.
- 10. Seat matrix process shall be available on the university website at the time of filling options/preferences College/Quota/Category for online counseling.
- 11. The admission for MBBS/BDS courses shall be made only to those institutions which have permission from all of the concerned authorities and affiliated with the University.

- 12. Allocation of seat is provisional subject to verification of original documents/checking of eligibility by the Principal of concerned Medical/Dental Colleges. It is sole responsibility of the Principal to authenticate the eligibility of the provisionally allocated candidates before their joining/admission.
- 13. The fee structure for the Government/Privately managed colleges is as per Punjab Government notification(s) for MBBS/BDS courses. If Punjab Government issues any subsequent amendment/corrigendum for change in fee structure, the same will be applicable in letter and spirit.
- 14. In case of any discrepancy or contradiction between the Government notification/s and The University instructions contained in this Prospectus, the letter and spirit of the notification(s) shall be prevailing, however in academic matters the University shall be the final Authority.
- 15. Deposition of fee does not confirm the admission of the candidate, if it is challenged in the Hon'ble Court.
- 16. Changes, if any, in the Schedule / Counseling etc. shall be notified only through website of the University i.e. <a href="https://www.bfuhs.ac.in">www.bfuhs.ac.in</a>
- 17. The allotment of College to the applicants for admission, shall be made as per merit determined on the basis of NEET-UG-2021 and the choice of the station opted by the candidate at the time of online counseling.
- 18. This is for the information of all candidates that as per Hon'ble Supreme Court of India, if any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him/her from the institution.

### 19. Post Matric Scholarship Scheme:

SC category candidates are entitled for scholarship from the Department of Welfare, Govt. of Punjab if they fulfill their terms and conditions. SC category candidates, whose family annual income from all sources is less than Rs. 2.5 lacs, are entitled for post matric scholarship as per guidelines of Govt. of India and Punjab Govt. The candidates will have to submit Freeship Card alongwith admission application from. For details regarding this scheme/forms/procedure, respective colleges/candidates should visit the website of Punjab Govt., Deptt. of Medical Education and Research (www.punjabmedicaleducation.org) and University website (www.bfuhs.ac.in). For any query/clarification, candidates/respective colleges can contact the office of Director, Medical Education and Research, Punjab, Chandigarh or Director, Welfare Deptt., Punjab, Chandigarh. For further information and applying for scholarship candidates may visit http://www.punjabscholarships.gov.in. It is also responsibility of the concerned candidate to ensure that has filled his/her application for scholarship is filled in time.

### 20. Application Fee


- (a) Admission Application Fee of Rs. 5900 (Rs.2950 for SC candidates) including GST @18% will be deposited through online payment gateway only.
- (b) Admission Application Fee will not be accepted in any form after due date/time in any case.
- (c) Only those Admission Application Forms will be considered for counselling, fee for which has been deposited by due date/time.
- (d) No request for accepting the Admission Application Forms after due date/time will be entertained.
- (e) Mere deposition of fee will not entitle the candidate for claim of admission.
- (f) Fee once deposited in University Account will not be refunded/adjusted in any case.

- 21. Notwithstanding the participation of candidates in counselling, only eligible candidates, as per Government notification(s), shall be considered for admission.
- 22. Candidates applying under any of the reserve category are directed to fill the right category code mentioned in this prospectus for claiming reservation under a category and also bring/attach all relevant documents/proof of respective category with admission application form and photocopies and original documents at the time of counseling/admission.
- 23. <u>Instructions for NRI Candidates only</u>:- Candidates who wants to apply under NRI quota seats, have to obtain provisional Eligibility/equivalency certificate from BFUHS, Faridkot and will have to qualify NEET-UG-2021 and candidates will apply on prescribed proforma available on website along with prescribed fee for seats under NRI Quota.

### **ELIGIBILITY CONDITIONS:**

- 1. The admission to MBBS/BDS Courses shall be open to candidates who have qualified NEET-UG-2021 and eligible as per Punjab Govt. notifications and subsequent amendment(s)/corrigendum(s) and as well as Punjab Govt. Personnel Department letter dated 06.06.1996.
- Merely applying for admission to MBBS/BDS courses on the basis of NEET-UG-2021 will not
  entitle the Candidates eligibility. A Merit of a candidate for admission will be determined by the
  Admission Committee strictly as per rules and regulations laid down in the Punjab Govt.
  Notification(s) as published in this prospectus and all other such documents as are required with
  the ADMISSION APPLICATION FORM.
- 3. Counseling/Admissions shall be conducted by the **Admission Committee** constituted by the Punjab Government for this purpose.
- 4. **Age:** As specified in NEET-UG 2021.

### **PROCEDURE OF ONLINE COUNSELLING**



### Step-I SUBMISSION OF ONLINE ADMISSION APPLICATION FORM

- 1. Candidates should read the Punjab Govt. notification and instructions as contained in the Prospectus carefully on University website i.e. <u>www.bfuhs.ac.in</u>.
- 2. Only NEET-UG-2021 qualified candidates are eligible to apply for admission to MBBS/BDS Courses.
- 3. Candidates are required to register themselves for admission to MBBS/BDS Courses through online portal by due date and time.
- 4. Candidates are advised to fill the online admission application form well in advance to avoid the network congestion in the last days. BFUHS will not be responsible for network congestion/problems. No request for accepting the forms after cut-off date will be entertained.
- 5. Following documents are required to be uploaded for the online registration:
  - I. Soft copy of Photograph of the candidate (Maximum size 30 KB).
  - II. Soft copy of the signatures of the candidate (Maximum Size 30 KB).

### **Specifications for Photograph:-**

- A colour photograph of minimum 35x45 mm with at least 75% coverage of face & head of the candidate.
- II. A caption indicating name of candidate and date of taking photograph should be there at the bottom of photo.
- III. Photograph should be taken in a white /very light colored background.
- IV. Photograph should not have cap or goggles. Spectacles are allowed if being used regularly. POLAROID and COMPUTER generated photos are not acceptable.
- V. The photograph needs to display full front view of the face. Please look directly into the camera with a neutral expression.
- VI. Please avoid photograph with reflection or shadow on the face.
- VII. The photograph needs to be printed on a high quality paper with at least 600 dpi resolutions.
- VIII. The colours must possess the natural appearance and skin tone.
- IX. The photograph must not have kinks, scratches and stains.

**Note:** Applications not complying with these instructions or with unclear photographs are liable to be rejected.

- After completion of filling online admission application form, University will issue a unique Registration ID (i.e. Login ID) and password to the candidate at his/her registered Mobile number through SMS/ email
- 8 Merely submission of online application form & fee does not confer any right to the candidate secure a seat for MBBS/BDS course.
- 9 No request for submitting online Admission Application Form after due date/time will be entertained on any ground.
- 10 Candidate shall submit online ADMISSION APPLICATION FORM only once. Applications submitted more than once are liable to be rejected.
- 11 Candidates are required to fill online Admission Application Form very carefully and should not leave any column blank, fill '0' (zero) in case of Roll Number/Rank/Marks are not available. However, a PDF file pertaining to steps for submission of online Admission Application Form will be uploaded on the University website (if required).
- After filling of successful online Admission Application Form, candidate has to deposit the fee through online payment gateway of University.
- **Step-II** Deposition of Fee:- Candidates will have to deposit the fee through online payment gateway of University.
  - (a) Registration for admission to MBBS/BDS courses is to be undertaken online at the University website www.bfuhs.ac.in.
  - (b) Application form for admission to MBBS/BDS courses submitted offline/printed copy shall not be accepted.

- (c) Incomplete application forms shall not be considered and are liable to be rejected. The fee shall not be refunded under any circumstances.
- (d) The allotment of College to the applicants for admission, shall be made as per merit determined on the basis of NEET-UG-2021 and the choice of the station opted by the candidate at the time of online counseling.
- 13. Candidates must strictly follow the instructions laid out in the Prospectus and University website. Candidates not complying with the instructions shall be disqualified.

### 14. Fill category carefully in the online Admission Application Form. Category once claimed will not be changed in any case after submitting the form.

Those candidates, who do not fill/claim any category code as per prospectus or fill a wrong category code other than mentioned in prospectus, will be treated in Open merit. The candidate may select a category code from the codes given below and fill the category accordingly. More than one category may be filled by a candidate if it is considered applicable in the candidate's particular case. Category codes are exclusively for the purpose of facilitating the candidates to know and understand his/her respective merit placement at the time of counseling in various reserved categories as have been filled by him/her. 1. Online counselling will be held through website where online counselling form will be available as per schedule specified in Important Dates.

### Step-V Filling of choices/preferences of course during online counselling

- 1. Only registered candidates are eligible for the counselling(s), no candidate shall be allowed to participate in the counselling (online/physical) without registration and deposition of fee before last date as prescribed.
- 2. The candidates should read the eligibility conditions carefully and just exercising online option of college / appearing in counselling does not entitle him/her for admission. Eligibility conditions for admissions are as per Punjab Govt. Notification(s). The eligibility shall be determined by the Selection Committee at the time of counseling. Those who are not eligible as per Punjab Govt. notification will not be considered for admission.

The Provisional Seat will be allocated as per NEET merit and in order of preferences given by the candidate. Therefore, candidates are advised to take proper caution while filling up the order of preferences of course, college, category, quota. Candidates of reserved categories (who scored marks equivalent or more than the minimum cut-off of open merit NEET marks) will also be considered in open merit. If candidate of reserve category is eligible in open merit, then seat of open merit will be allocated.

- 4. After provisional allocation of seat, candidates can download provisional allocation letter from the University website after logging into their account will deposit the tuition fee through online payment gateway and report to the respective college along with all original documents for the checking of documents and their eligibility. Issuing of Provisional Selection Slip alone does not confer any right to claim the allocation of seat in respective college as their provisional selection is subject to verification of documents and checking of eligibility as per guidelines of Punjab Govt. Notification enshrined in the Prospectus.
- 5. If any candidate does not follow the said process, his/her allocated seat will be cancelled automatically without any intimation and his/her seat shall be declared as vacant for the subsequent round of counseling.
- 6. If candidate is satisfied with seat allocated to him/her during online counselling, he/she is not required to participate in the subsequent round of counsellings. In case, candidate wishes/intends to upgrade/change his/her seat he/she will have to participate in the subsequent round of counselling and give his/her preferences afresh for the course/college/category/quota.
- 7. In case any candidate wants to quit the course/seat, he/she will have to submit application to the respective college regarding his/her surrender of seat well in advance before the start of next round of counselling.



- The Government of Punjab is pleased to notify the admission criteria to Undergraduate Degree courses of MBBS and BDS for the year 2021 onwards in the Government & Private Medical/Dental Institutes, including Institutes under Private Universities and Minority Institutions in the State of Punjab.
- 2. All admissions of Govt. Quota seats/Management Quota Seats, including and any Minority Quota seats, and any other Seats, whatsoever, in the Government & Private Medical/Dental Institutes, including Institutes under Private Universities and Minority Institutions shall be based on the merit of National Eligibility-cum-Entrance Test (NEET).
- The Government of Punjab is pleased to authorize Baba Farid University of Health Sciences, Faridkot (BFUHS) to conduct centralized counselling for admissions, for seats as spelled out at Sr. No. 2, on the basis of marks obtained in NEET.
- 4. Eligibility criteria for admission in Government & Private Medical/Dental Institutes, including Institutes under Private Universities and Minority Institutions for MBBS and BDS seats, as spelled out at Sr. No. 2 shall be in accordance with eligibility criteria/ qualifications/qualifying criteria as prescribed in the Information Bulletin for National Eligibility-cum- Entrance Test (NEET) issued by NTA (National Testing Agency) for the corresponding year.
- 5. After the declaration of the NEET result, the candidates shall apply on the specific proforma for all seats, except All India quota seats, to Baba University of Health Sciences, (BFUHS), Faridkot. Admission shall be made by the Admission Committee through a Centralized Counselling by BFUHS, Faridkot on the basis of inter-se merit of NEET.
- 6. Admissions to Private institutions/Universities shall also be governed by the provisions of Para 2 above and also as per the provisions of the "Punjab Private Health Sciences Educational Institutions (Regulation of Admission, Fixation of Fee & Making of Reservations) Act, 2006." and its Amendment Act 2020.

- 7. A candidate from reserved Category shall have the right to compete for admission in General/Unreserved category seats as per his/her merit on the day of counselling and candidate so selected shall not be counted towards admission in the reserve category.
- 8. The schedule of counselling, admission and start of classes shall be in conformity with the schedule laid down by National Medical Commission / Dental Council of India/ Hon'ble Supreme Court of India/ State Government. Fee and other charges for submission of the application and counselling shall be notified by BFUHS as per Government approval.
- 9. Out of the total seats in Government Institutes, 15% seats (All India Quota) in MBBS/BDS courses shall be filled by the Government of India through Centralized Counselling by Medical Counselling Committee of DGHS, MOHFW, Govt. of India on the basis of marks obtained in NEET. Rest seats shall be filled by the Admission Committee constituted by the Government of Punjab, as per merit of NEET.
- 10. The details of the institutions and category wise seats shall be available on the official website of Baba Farid University of Health Sciences, Faridket i.e. www.bfuhs.ac.in.
- 11. The candidate should be a bonafide resident of Punjab. The resident status of Punjab state shall be taken in terms of Punjab Government, Department of Personnel and Administrative reforms (PP-II Branch) letter No. 1/3/95-3 PP II/9619, dated 6<sup>th</sup> June,1996, and any further instructions issued by the Department of Personnel, if any, and the same shall be adhered to. The Candidate and his parent / guardian shall submit a sworn declaration that the candidate has not passed the qualifying examination from more than one Board / University and has not obtained admission in MBBS/BDS course in any other State / UT, except under All India Quota Seats.

### 19. Candidates already admitted:-

Any candidate, who has taken admission in the previous session in MBBS/BDS course, shall be eligible to seek admission again in the same course, like a fresh applicant based on marks of NEET in the year of consideration on the basis of NOC issued by the college where he is presently pursuing MBBS/BDS.

### 20. GENERAL CONDITIONS

- a) The University shall display combined merit list of all candidates including reserve category and also a separate merit list of different categories which should be displayed on the University website at least 7 days before the counseling.

In case of candidates whose parents are not alive, the dependency certificate shall have to be taken from the Deputy Commissioner / District Collector of the District or any other Government official duly authorized by the State Government or Deputy Commissioner / District Collector where the candidate resides.

f) The reservation for SC shall be calculated on total seats of an institution after deduction of All India Quota seats.

- h) Scheduled Caste/ Backward Classes category candidates shall be eligible to apply for Post-Matric Scholarship and reimbursement of fee if they fulfill the terms and conditions laid down by Department of Welfare, Govt. of Punjab.
- The Reservation of Physically Challenged persons shall be as per the provision of Right of Persons with Disability Act 2016.

Aspirants for the UG-2021 in State of Punjab are required to approach any of the designated centre ( as per list available on Medical Counseling Committee website mcc.nic.in) approved by the Govt. of India for issuing of disability certificate for the 21 benchmark described under RPWD Act 2016. Candidates shall bring the valid certificate in the prescribed format from any of the designated centre on the day of counselling. No separate medical board will be constituted for the admission under this category and no other disability certificate in this regard shall be entertained.

- Guidelines of MCC shall be followed and referred to, from time to time in the process of counseling.
- k) Seats remaining vacant under any of the reserve / minority category shall be transferred to the General Category.
- For students admitted through online counseling, fee shall be deposited as prescribed by Baba Farid University of Health Sciences, Faridkot after verification of documents at College level. For students admitted through physical counseling, fee shall be deposited through Bank Demand Draft only
- 21. The State Government reserves the right to amend any clause and procedure for admission.
- 22. In case of any doubt, the Administrative Secretary, Department of Medical Education & Research, Government of Punjab may issue clarification which will have force of the policy.

Sir/Madam,

I am directed to invite your attention to the Punjab Government Circular Letter No.1/3/95-3PP II/2043, dated 29/1/1996 vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of Domicile for purposes of admission to educational institutions (including technical/medical institution). The matter has been reconsidered in the light of judgement delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain Vs. Union of India and others reported as AIR 1984-SC-4121 wherein it was held that instead of the word 'Domicile' the word 'Residence' be used in the instructions issued by the State Government on the subject. Accordingly, it has been decided by the Government to revise the Government instructions referred to above as under:

Affidavit/Certificate and the authorities competent to issue the same

(a) Citizen of India

(b) Produce an affidavit to the effect that they or their Children/wards have not obtained the benefit of Residence in any other State

Affidavit of the parents/guardian to be attested by an Executive Magistrate/Oath

Commissioner/Notary Public

#### Categories

- Candidates who have studied for a period of 5 years in Punjab or have studied in Punjab for 2 years just preceding the qualifying examination for the admission.
- ii) Children wards of
  - a) The employees of Punjab Govt. posted in or outside Punjab State or working on deputation having at least 3 years of service.
  - b) The employee of Govt. of India posted in Chandigarh or in Punjab in connection with the affairs of the Punjab Govt. for a period of 3 years.
  - c) The employees of State Govt. institutions/undertakings who are posted in Chandigarh or in Punjab in connection with the affairs of the Punjab Govt. for a period of 3 years.

With reference to letter No.1/3/95-3PII/9619, dated the 6th June, 1996 of this Department on the subject noted above and to say that keeping in view the hardship being faced by the Employees in getting the 'Residence Certificate' it has been decided to decentralize the powers of issuing the 'Residence Certificate' in process of the categories mentioned below:

#### **Categories:**

- ii) Children/wards of
- a) The employees of Punjab Government posted in or outside Punjab State or working on deputation having at least 3 years of service.
- the employees of Government of India posted in Chandigarh or in Punjab in connection with the affairs of the Punjab Government for a period of 3 years.
- c) the employees of State Government institutions/undertaking who are posted in Chandigarh or in Punjab in connection with the affairs of the Punjab Government for a period of 3 years.
- the employees having at least 3 years of service in autonomous bodies/ companies in which Punjab Government has 20% or more shares.

The Heads of the office shall be competent to issue the requisite certificate to the employees with the exception that in the case of head of Office, the Head of the Department shall be the Competent Authority to issue the certificate

From: Chief Secretary to Government of Punjab to all the Heads of the department etc.

Subject: Issuance of certificate for the purpose of seeking admission to various educational/technical/professional institutions in the state and also for employment.

Sir,

It has been brought to the notice of Government that educational authorities and institutions prescribe various certificates regarding residence, SC/BC category and backward area etc. to be furnished by the students/candidates with the applications forms for entrance examinations or employment in the formats and by the authorities different from those prescribed by the Government departments. Cases have also been reported where the authorities concerned insist on retaining original certificates and refuse to accept the attested photo copies of the certificates. All this results in harassment and panic among the students/candidates and their parents/guardian, since they have to apply with such certificates to more than one authorities simultaneously and within a limited period. The lists of certificates required at the time of applying for CET/PMET/PMT and PAU are enclosed by way of illustration.

- 2. In order to overcome the difficulty mentioned above, it has been decided by the Government that following procedure has been decided by the Government that the following procedure shall be followed meticulously by all the educational and other authorities concerned:-
- i) Certificates issued in the format and by the authorities prescribed by the Government Departments shall be accepted as valid by all educational institutions and other authorities.
- ii) Where a number of authorities have been authorized to issue the certificates there shall be no insistence on issue of a certificate by any particular authority or by the highest authority indicated in the format.
- iii)(a) In case of entrance examinations, no certificate should be called for in the first instance alongwith the application form. It will be sufficient for the candidate seeking admission or other facility to indicate in the application from whether he/she belongs to any particular category entitling him/her to certain concessions or facility. Requisite certificates may be obtained only from the selected/wait listed candidates.
- iii)(b) To further simplify the procedure attested copies of the certificates only shall be retained and original certificates if required to be produced at the time of interview shall be returned immediately, thereafter.
- iv) Parents / guardian or candidates can also obtain SC certificates from the Head of the institution where the candidate has studied if the proof is available in the school records.
- v) The persons who are employed in Government of India or any other State Government are to be treated at par with the employees of the Government of Punjab in the matter of issue of Scheduled Caste certificate provided relevant Scheduled Caste certificate exists in their service record. # MEDICAL COUNCIL OF INDIA AMENDMENT NOTIFICATION

New Delhi, the 18th May, 2018

No.MCI-34(41)/2018-Med./109835.— In exercise of the powers conferred by Section 33 of the Indian Medical Council Act, 1956 (102 of 1956), the Medical Council of India with the previous sanction of the Central Government,

hereby makes the following Regulations to further amend the "Regulations on Graduate Medical Education, 1997", namely: -

- 1. (i) These Regulations may be called the "Regulations on Graduate Medical Education (Amendment), 2018.
  - (ii) They shall come into force from the date of their publication in the Official Gazette.
- 2. In the "Regulations on Graduate Medical Education, 1997", following clause shall be added after 5A(3):-
  - 5A(4) In order to prevent seat blocking in common counseling for admission to MBBS course and permissibility to exercise fresh choice during counseling, forfeiture of fee shall be in accordance with the Matrix contained in "Appendix F".
- 3. In the "Regulations on Graduate Medical Education, 1997", in Appendix 'F' the following "Note" shall be added below the Time Schedule for completion of the admission process for first MBBS course for the academic year 2018-19 and onwards:

#### Note:

- All India Quota Seats (15%) remaining vacant after last date for joining, i.e. 22<sup>nd</sup> July of the present Admission year will be deemed to be converted into State quota.
- Institute/college/courses permitted after 31st May will not be considered for admission/ allotment of seats for current academic year.
- 3. In any circumstances, last date for admission/joining will not be extended after 31st August.
- 4. For the purpose of ensuring faithful obedience to the above time-schedule, Saturday, Sunday or Holidays (except National Holiday on account of Independence Day, 15th August) shall be treated as working days.
- 5. The following Matrix shall be applicable with regard to permissibility to students to exercise fresh choice during counseling:-
