COBSE (Council of Boards of School Education in India) grants membership to boards/Institutions that are set up by an Act of Parliament or State Legislature or by an Executive orders of the Central/State Government and broadly follow the National Curriculum Framework/CBSE. Therefore, candidates who have passed their qualifying examination from member-boards of COBSE are acceptable for admissions. A complete list of member-Boards of COBSE can be download from www.cobse.org. Boards not in the list of member –Boards of COBSE shall not be acceptable for admissions. The Board of Management resolved that the list of Boards recognized by COBSE shall be considered for admission to higher courses run by the University.

Important Instructions (PLEASE READ IN DETAIL)

- 1. Eligibility and qualifications will be as per Punjab Govt. Notification No.5/3/2011-5HBIII/10455 dated:29.12.2019 and other corrigendum's. **Candidates must be NEET UG-2021 qualified.**
- **2.** Distribution of seats will be as per Punjab Govt. Notification, the list of eligible colleges/seats may increase/decrease, subject to the orders of Hon'ble Courts/NCISM/NCH /Govt. The final list of seats will be displayed at the time of counselling.
- 3. Correction(s) In Online Registration/Counselling In case candidate wants to make any change in his/her online form, he/she can do the same by logging on again in his/her online application form by using the password provided by the University on or before the last date for submission of form. Online Admission Application Form will be locked automatically after the cut-off date for submission of online admission application form. No request for any correction in admission application form will be considered thereafter. Filling more than one form by one candidate may cause cancellation of the candidature.
- 4. Candidates of category of Scheduled Caste (Category Code 12), Backward Classes (Category Code 13), Schedule Tribe (Category Code 33), Other Backward Classes (Category Code 35) will report at the allotted college along with original certificate for physical verification of documents and checking of eligibility.
- 5. Sports Category Candidates:-The candidates who applied under Sports Category (Category Code 17), will submit printed/hard copy of online submitted form **personally (by hand)** in the allocated college along with Sports Gradation Certificate issued by the Director, Sports, Punjab and other supporting self attested copies of certificates/documents.
- 6. Candidates of category Backward Area (Category code 14), Border Area (Category Code 15), Physically Handicapped (Category Code 16), Riot/terrorist affected (Category Codes- 18(1), 18(2), 19, 20(1), 20(2), 21) and Freedom Fighter (Category Code 31) will report at allocated college along with original certificate for physical verification of documents and checking of eligibility.
- 7. Candidates of categories wards of defence personnel (Category Code 22 to 26), wards of Punjab Police Personnel, Punjab Armed Police, Punjab Home Guards and Para-Military Forces (Category Codes-28 to 30) and Migrants from Jammu & Kashmir due to terrorist violence (Category Code 32) will report at allocated college along with original certificate for physical verification of documents and checking of eligibility.
- 8. Candidates of category of Economically Weaker Sections (Category Code 34) will report at the allotted college along with original certificate for physical verification of document issued from the office of Tehsildar for checking of eligibility.
- **9.** Allocation of seat is provisional subject to verification of original documents/checking of eligibility by the Principal of concerned Ayurvedic/Homoeopathy/Unani Colleges. It is the sole responsibility of the Principal to authenticate the eligibility of the provisionally allocated candidates before their joining/admission.
- 10. Correct category must be filled carefully in the online application form. No claim shall be allowed if category/categories are not indicated in online application form. Only those candidates who claim Reservation by filling categories code in online application form shall be considered for reserved seat.
- **11.** After last date of submission of online Registration Form, no request will be entertained for any change therein.
- **12.** Only registered candidates are eligible for the counselling(s) and without registration, none of candidates is allowed for the counselling (online).
- 13. 15% seats are of All India Quota and remaining 85% seats are of State Quota.

INTRODUCTION

BRIEF HISTORY:

Guru Ravidas Ayurved University Punjab, Hoshiarpur was created with the promulgation of the Guru Ravidas Ayurved University Punjab Act, 2009 (Punjab Act No. 4 of 2010) by the Punjab Legislative Assembly. The University started functioning w.e.f. 01.02.2011 in rented building of Panchayat Bhawan, Hoshiarpur. The main campus of the University is located in the foothills of Himalayas on Hoshiarpur-Una Road in 33 Acre of Land in village Kharkan (10 KM from Hoshiarpur city). The University has its own well constructed Administrative Block in approximately 5 Acre of land. This University regulates the conduct of undergraduate post-graduate Ayurvedic, Homeopathic, Unani and Ph.D teachings.

UNIVERSITY'S PRESENT STATUS:

This University is one of its own kinds in North India. At present the University has total 20 affiliated colleges viz 16 Ayurvedic, 3 Homoeopathy and 1 Unani college. The P.G training in 3 M.D Ayurvedic and 1 Homoeopathic colleges in various departments are being imparted under the affiliation of this University. The University has started Ph.D in four departments of Ayurveda from the year 2020. It has about 6,000 registered students presently undergoing undergraduate. Postgraduate and Ph.D studies.

In addition to the academic activities, the University has also been providing health care services through its AYUSH OPD to the people of nearby villages.

The University has been striving to bring about major development in AYUSH and all basic, clinical and allied departments to pursue on education and research. Meritorious AYUSH faculties from all over the country are getting aspired to work in this University.

IMPORTANT GENERAL INSTRUCTIONS (PLEASE READ IN DETAIL)

- 1. Registration for admission to BAMS/BHMS/BUMS courses is to be undertaken online at the University website.
- 2. Application form for admission to BAMS/BHMS/BUMS courses cannot be submitted offline/printed copy by post.
- 3. This prospectus contains two parts:
 - **Part-A** Pertains to the general procedure for applying to admission, submission of admission application/counselling form, deposition of fee, important instructions, joining, etc.
 - **Part-B** Pertains to Punjab Govt. Notifications for admission to BAMS/BHMS/BUMS Courses proforma for different categories, self undertaking, etc.
- 4. Candidates must follow the instructions strictly as given in the Prospectus and University website. The applications of the candidates shall be summarily rejected, who will not complying with the instructions.
- 5. Incomplete application not in accordance with instructions shall not be considered and are liable to be rejected. The fee once deposited shall not be refunded under any circumstances.
- 6. This prospectus is subject to alteration(s) / modification(s) at any time without notice. For updates please visit University website from time to time.
- 7. Instructions in this prospectus are liable to changes based on decision/s taken by the Punjab Government/University from time to time. There is no equity or any rights that are/or deemed to be arising in favour of candidate.
- 8. Admissions including Eligibility to BAMS/BHMS/BUMS Courses shall be governed and regulated as per the rules and regulations etc, as per Punjab Govt. notifications.
- 9. The candidate should read the eligibility condition carefully and just applying for admission/counselling does not entitle him/her for admission. Eligibility conditions for admissions are given in the Notification. The eligibility shall be determined by the Selection Committee/Principal of concerned college at the time of counseling/admission. Those who are not eligible as per Punjab Govt. notification will not be considered for admission. The candidates will participate in counselling process at their own risk & responsibility. Eligibility is also subject to medical fitness and such criteria as may be prescribed by the Punjab Government/ University/Medical institutions/ NCISM/NCH
- 10. Candidates' eligibility is purely provisional & subject to the fulfillment of eligibility criteria as Punjab Government Notification incorporated in this prospectus.
- 11. Applications of candidates producing false or fabricated documents/information shall not be considered and candidates shall be further debarred from participating in any Counseling's conducted by GRAU, Hoshiarpur.
- 12. Any attempt by a candidate to influence directly or indirectly any person concerned with the admission will disqualify him/her.
- 13. Final seat matrix shall be available on the University website at the time of filling options/preferences College/Quota/Category for online counseling.
- 14. The admission for BAMS/BHMS/BUMS courses shall be made only to those institutions which have permission from all of the concerned authorities and affiliated with the University.
- 15. The fee structure for the Government/Privately managed colleges is as per Punjab Government notification(s) for BAMS/BHMS/BUMS courses. If Punjab Government issues any subsequent amendment/corrigendum for change in fee structure, the same will be applicable in letter and spirit.
- 16. In case of any discrepancy or contradiction between the Government notification/s and the University instructions contained in this Prospectus, the letter and spirit of the

- notification/s shall be prevailing, however in academic matters the University shall be the final Authority.
- 17. Deposition of fee does not confirm the admission of the candidate, if it is challenged in the Hon'ble Court.
- 18. Changes, if any, in the Schedule / Counselling etc. shall be notified only through website of the University i.e. www.graupunjab.org
- 19. Candidates must retain the copy of prospectus with them till admissions. They should read carefully the instructions and the rules & regulations of the Punjab Govt. Notification/s and comply with all instructions therein strictly.
- 20. The allotment of College to the applicants for admission, shall be made as per merit determined on the basis of NEET-UG-2021 and the choice of the station opted by the candidate at the time of online counselling.
- 21. This is for the information of all candidates that as per Hon'ble Supreme Court of India, if any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him/her from the institution.
- 22. All the candidate must have read the Punjab Govt. notification/instructions as contained in the Prospectus carefully on University website www.graupunjab.org before filling online admission application form.
- 23. Candidates will fill only online admission application form through GRAU website i.e. www.graupunjab.org. Candidates are advised to fill online admission application form before the due date. Online Admission application form will not be available on University website after the due date/time. Candidates are advised to fill the online admission application form well in advance to avoid the network congestion in the last days. GRAUH will not be responsible for network congestion/problems. No request for accepting the forms after cut-off date will be entertained.
- **24.** State Merit list will be prepared for different categories in which candidate applies, on the basis of NEET(UG)-2021 ranking.
- 25. Post Matric Scholarship Scheme: Scheduled Caste/Backward Classes category candidates shall be eligible to apply for the Post-Matric Scholarship and reimbursement of fee if they fulfill the terms and conditions laid down by Department of Welfare, Govt. of Punjab. For details regarding this scheme/forms/procedure, colleges/candidates should visit the website of Punjab Govt., Deptt. of Medical Education Research (www.punjabmedicaleducation.org). For any query/clarification, candidates/respective colleges can contact the office of Director, Medical Education and Research, Punjab, Chandigarh or Director, Welfare Deptt., Punjab, Chandigarh. For further applying for scholarship candidates http://www.punjabscholarships.gov.in. It is also the responsibility of the concerned candidate to ensure that college has filled his/her application for scholarship in time.

26. Application Fee

- a) Admission Application Fee of Rs. 4600 (Rs.3750 for SC candidates) will only be deposited through Debit card/Credit Card/Netbanking after successful filling of online admission application form on university website.
- b) Admission Application Fee will not be accepted in any form after due date/time in any case.
- **c)** Only those Admission Application Forms will be considered for counselling, fee of which has been deposited by due date/time.
- d) No request for accepting the Admission Application Forms after due date/time will be entertained.
- e) Merely deposition of fee will not entitle the candidate for claim of admission.

- f) Fee once deposited in University Account will not be refunded/adjusted in any case.
- 27. Notwithstanding the participation of candidates in counselling, only eligible candidates, as per Government notification/s, shall be considered for admission.
- 28. Candidates applying under any of the reserved category are directed to fill the right category code mentioned in this prospectus for claiming reservation under a category and also bring/upload all relevant documents/proof of respective category with admission application form and also directed to bring along photocopies and originals documents at the time of counseling/admission.
- 29. Instructions only for NRI Candidates:- Candidates who want to apply under NRI quota seats, have to obtain provisional Eligibility/equivalency certificate from the GRAU, Hoshiarpur and must have to qualify NEET-UG-2021 and candidates will apply on prescribed Proforma available on University website along with prescribed fee for NRI seats
- 30. Annexure -I (Page no-43) & Annexure- V (Page no-66) is compulsory for all the candidates applying for admission.
- 31. Please visit our website **www.graupunjab.org** for all regular and updated information concerning admissions/dates of counselling from time to time.

- (i) "BAMS" means Bachelor of Ayurvedic Medicine and Surgery.
- (ii) "BHMS" means Bachelor of Homoeopathic Medicine and Surgery.
- (iii) "BUMS" means Bachelor of Unani Medicine and Surgery.
- (iv) "GRAUP" means Guru Ravidas Ayurved University Punjab, V.P.O Kharkan, Hoshiarpur.
- (v) "Council" means the national statutory council regulating a particular discipline such as:-
 - 'CCIM' means Central Council of Indian Medicine.
 - 'CCH' means Central Council of Homoeopathy.
 - 'NCISM" means National Commission for Indian System of Medicine
 - 'NCH' means National Commission for Homoeopathy
- (vi) "Eligible Candidate" means a candidate who satisfies the requirements of eligibility as prescribed in the Prospectus / Government Notification and corrigendum issued from time to time and other notifications issued for this purpose from time to time and the criteria of Guru Ravidas Ayurved University Punjab, Hoshiarpur.
- (vii) "Government Notification" means Notification No. No.5/3/2011-5HBIII/10455 dated:29.12.2021 and corrigendum issued from time to time and other notifications issued for this purpose from time to time by the Department of Medical Education & Research.

ELIGIBILITY CONDITIONS

- 1. The **admission to BAMS/BHMS/BUMS Courses** shall be open to candidates who have qualified NEET UG-2021 and are eligible as per Punjab Govt. notifications and subsequent amendment(s)/corrigendum(s).
- 2. Merely applying for admission to BAMS/BHMS/BUMS courses on the basis of NEET-UG-2021 will not entitle the Candidates eligible, eligibility and Merit of a candidate for admission will be determined by the Selection Committee strictly as per rules and regulations laid down in the Punjab Govt. Notification(s) as published in this prospectus and all other such documents as are required with the ADMISSION APPLICATION FORM.
- **3.** Counseling/Admissions shall be conducted by the **Admission/Selection Committee** constituted by the Punjab Government for this purpose.

4. Age as per NEET-UG 2021.

INSTRUCTIONS FOR FILLING UP ONLINE ADMISSION APPLICATION FORM

- 1. Candidates will have to log on University website i.e. www.graupunjab.org and read the Punjab Govt. notification and instructions as contained in the Prospectus carefully.
- 2. NEET-UG-2021 qualified candidates are eligible to apply **ONLINE** for admission to BAMS/BHMS/BUMS Courses.
- 3. Candidates are required to register themselves for admission to BAMS/BHMS/BUMS Courses through online registration system at GRAU website i.e. www.graupunjab.org. Online registration must be completed by due date and time.
- 4. Candidates are advised to fill the online admission application form well in advance to avoid the network congestion in the last days. GRAU will not be responsible for network congestion/problems. No request for accepting the forms after cut-off date will be entertained.
- 5. Following documents are required to upload on the online registration form:
 - I. Soft copy of Photograph of the candidate. (Maximum size 30 KB)
 - II. Soft copy of the signatures of the candidate. (Maximum Size 30 KB)
- 6. Specifications for Photograph:-
 - I. A colour photograph of minimum 35x45 mm with at least 75% coverage of face &head of the candidate.
 - II. A caption indicating name of candidate and date of taking photograph should be there at the bottom of photo.
 - III. Photograph should be taken in a white /very light colored background.
 - IV. Photograph should not have cap or goggles. Spectacles are allowed if being used regularly. POLAROID and COMPUTER generated photos are not acceptable.
 - V. The photograph needs to display full front view of the face. Please look directly into the camera with a neutral expression.
 - VI. Please avoid photograph with reflection or shadow on the face with red eyes.
 - VII. The photograph needs to be printed on a high quality paper with at least 600 dpi resolutions.
 - VIII. The colours must possess the natural appearance and skin tone.
 - IX. The photograph must not have kinks, scratches and stains.

Note: Applications not complying with these instructions or with unclear photographs are liable to be rejected.

- 7. After completion of filling online admission application form, University will issue a unique Registration ID (i.e. Login ID) and password will be provided to the candidate at his/her registered Mobile number in admission application form through SMS/ email. Registration Number and password are mandatory for further process, so keep it secret and don't disclose to any unknown person.
- 8. Merely submission of online application form & fee does not confer any automatic rights to secure a BAMS/BHMS/BUMS seat.
- 9. Please visit GRAU, Hoshiarpur website www.graupunjab.org for all regular and updated information concerning admissions/Date of counselling from time to time.
- 10. No request for submitting online application after due date/time will be entertained on any ground.
- 11. Candidate shall fill online ADMISSION APPLICATION FORM only once. Applications submitted more than once are liable to be rejected.
- 12. Candidates are required to fill online admission application form very carefully and should not leave any column blank, fill '0' (zero) in case of Roll Number/Rank/Marks are not available.
- 13. **Depositing Fee: -** After filling of successful online admission application form, Candidates will have to deposit the fee through payment gateway using Debit Card/Credit card/Net Banking.
- 14. Take printout of the online filled admission application form.

15. Fill category(ies) carefully in the online admission application form. Category(ies) once claimed will not be changed in any case after submitting the form.

Those candidates, who will not fill/claim any category code as per prospectus or wrongly filled category code other than mentioned in prospectus, will be treated as Open/General Category candidate. The candidate may select a category code from the codes on page No 14 and fill the category accordingly. More than one category may be filled by a candidate if it is considered applicable in the candidate's particular case. Category codes are exclusively for the purpose of facilitating the candidates to know and understand his/her respective merit placement at the time of counselling in various reserved categories as might have been filled by him/her. Reserved category selection on the part of the candidate shall not in any case be construed to give him/her any legitimacy or right or claim on the benefits for reserved seats during admission. Claims to admissions against reserved seats in BAMS/BHMS/BUMS courses will be on the basis of appropriate claims made in the Admission Application Form subject to rules and regulations contained in the Punjab Government Notifications printed in the Part-B of this prospectus and as per the decisions of the Selection Committee constituted for this purpose by the Punjab Government. No benefit of reservation whatsoever shall be given if the claim is not made in Admission Application Form.

STEPS FOR ONLINE COUNSELLING:-

- NEET-2021 qualified candidates shall visit University website i.e. www.graupunjab.org and fill the online registration form carefully within stipulated date & time. After successful registration of the applicant, a unique Registration ID (i.e. Login ID) and password will be allotted to the candidate at his/her registered Mobile No. or email through SMS or by email. Registration ID and password are mandatory for further process, so keep it secret and don't disclose to any unknown person.
- 2. Registration Fee for State Quota Candidates is Rs. 4,600/- (Rs. 3750/- for SC candidates) and for All India Quota candidates is Rs. 2,000/-
- 3. The candidate has to deposit the requisite fee through Payment Gateway using Debit Card/Credit Card/Net Banking.
- 4. Only registered candidates are eligible for the counselling(s) and without registration, none of candidates are allowed for the counselling (online/physical).
- 5. In the online application form candidate shall carefully fill the particulars viz; Name/Father Name/Preference of course / College/Category/Quota/NEET-2021 Marks, etc.
- 6. Candidates can fill their institutional preferences for getting their seats in the 1st round of counselling.
- 7. The seat will be allotted to the candidate as per merit list and institutional preferences filled by him/her in the online application form. The candidate has to report to his/her respective college for checking of eligibility, document verification and medical checkup. The candidates are required to produce his/her original documents/credentials for verification.
- 8. After the verification of the documents and checking of eligibility, candidate will deposit fee in the shape of demand draft of nationalized bank in the favour of Registrar Guru Ravidas Ayurved University payable at Hoshiarpur.

INSTRUCTIONS FOR ONLINE COUNSELLING

- 1. Online counselling will be conducted through University Website and online counselling form will be made available on University website as per dates specified in Important Dates column.
- In case of physical counselling, personal appearance of candidates is essential at the time of interview/counseling and exemptions from personal appearance may not be sought as it shall not be granted.
- 3. The candidates should read the eligibility conditions carefully and just exercising online option of college/ appearing in counselling does not entitle him/her for admission.
- 4. Eligibility conditions for admissions are as per Punjab Govt. Notification(s). The eligibility shall be determined by the Admission Committee at the time of counseling. Those who are not eligible as per Punjab Govt. notification will not be considered for admission. The candidates will appear in counselling at their own risk & responsibility.
- 5. The allotment of seat and college shall be made as per the choice of the candidate at the time of the counselling by the Admission Committee on the basis of the merit determined as per marks obtained by the candidate in NEET-UG-2021 and other terms and conditions contained in the Punjab Government Notification for admission to BAMS/BHMS/BUMS Courses.
- The candidates shall have to produce all the certificates/degrees/diplomas/ documents in original at the time of joining/admission in respective colleges or at the time of physical counseling.
- 7. The choice(s) of courses/ institutions shall be exercised by the candidate at the time of Counseling/ interview.
- 8. Checking/Verification of Original Certificate/Documents: Allocation of seat is provisional subject to verification of original documents/checking of eligibility by the Principal of concerned Ayurvedic/Homoeopathy/Unani Colleges. After provisional allocation of seat, candidate shall have to report to the allocated college for getting challan form, verification of documents and checking of eligibility. It is the sole responsibility of the Principal to authenticate the eligibility of the provisionally allocated candidate before their joining/admission.
- 9. Deposition of Annual Fee after provisional allocation: Candidate will deposit tuition fee (as per Punjab Govt. notification) in the form of Demand Draft in the favour of Registrar Guru Ravidas Ayurved University, Payable at Hoshiarpur. Candidate will report for medical checkup and joining after submission of proof of fee deposition to the respective college within stipulated time period, failing which allocated seat will stand cancelled automatically without any intimation to the candidate.
 - In case of physical counselling candidate will have to deposit tuition fee as specified in the Punjab Govt. notification on the spot at the venue of counselling in the shape of Demand Draft in favour of "Registrar, Guru Ravidas Ayurved University" payable at "Hoshiarpur" failing which his/her provisional selection will be treated as cancelled without any intimation to the candidate.

PROCEDURE OF ONLINE COUNSELLING AND JOINING AT THE COLLEGES

First two/three round of counseling for admission to BAMS/BHMS/BUMS course NEET-UG-2021 will be conducted through online mode and thereafter Physical counseling will be conducted. During online counselling, candidates will fill online counselling form therein they will opt for their preferences of course, college, category, quota. Seat will be allocated as per the merit of NEET-UG – 2021 and order of preferences given by the candidate. Therefore, candidates are advised to take care during filling up the order of preferences of course, college, category, quota. Candidates of reserved categories will also be considered in open merit, if open merit seat is available then seat of open merit will be allocated to them else seat of reserved category will be allocated.

There will be two rounds of online counselling and subsequent round of physical counselling. After provisionally allocation of seat, candidates can download provisional allocation letter from the University website after login to their account and report to the respective college along with all original documents for the checking of documents and their eligibility. After checking of their original documents and eligibility, candidate will deposit fee in the shape of demand draft of nationalized bank in the name of Registrar Guru Ravidas Ayurved University payable at Hoshiarpur. After depositing tuition fee, candidates will again report at the provisionally allocated college for their joining and medical checkup. If any candidate does not follow the said process his/her allocated seat will be cancelled automatically without any intimation.

If candidate is satisfied with seat allocated to him/her during online counselling, he/she is not required to participate in the subsequent round of counsellings. In case, candidate wants to upgrade/change his/her seat he/she will have to participate in the subsequent round of counselling and give his/her preferences afresh for the course/college/category/quota.

In case any candidate wants to quit the course/seat, he/she will have to submit application to the respective college for surrender of seat well in advance before start of next round of counselling.

In case the seat of a candidate is upgraded/changed in the subsequent round of counselling and he/she has already deposited the tuition fee, he/she is not required to deposit fee again, provided he/she has to deposit difference in fee, if any.

- The Government of Punjab is pleased to notify the admission criteria to Undergraduate Degree courses i.e. BAMS, BHMS and BUMS for the year 2021 onwards in the Government & Private Ayurvedic, Homoeopathic and Unani Institutes in the State of Punjab.
- 2 All admissions to Govt. Quota seats/Management Quota seats, including NRI and any other seats, whatsoever in the Government & Private Ayurvedic/Homoeopathic/Unani institutes, shall be based on the merit of National Eligibility-cum-Entrance Test (NEET) conducted by National Testing Agency (NTA).
- 3 The Government of Punjab is further pleased to authorize Guru Ravidas Ayurved University Punjab, Hoshiarpur to conduct centralized counselling for admission to BAMS/BHMS/BUMS on the basis of marks obtained in NEET.
- 4 After the declaration of NEET result, the candidates shall apply on the specific Performa for all seats to Guru Ravidas Ayurved University Punjab, Hoshiarpur. Admission shall be made by the Admission Committee through a Centralized Counseling to be conducted by Guru Ravidas Ayurved University Punjab, Hoshiarpur on the basis of inter-se-merit of NEET. Fee and other charges for submission of application and counseling to be charged by the University shall be Rs. 3750/- for SC/ST candidates and Rs. 4600/- for all other candidates.
- The Schedule of counseling, admission and start of classes shall be in conformity with the schedule laid down by Govt. of India, Ministry of AYUSH/State Govt. and shall be notified on the website of Guru Ravidas Ayurved University Punjab, Hoshiarpur i.e. www.graupunjab.org.
- The detail of the Institutions and category-wise seats matrix shall be available on the
 website of Guru Ravidas Ayurved University Punjab, Hoshiarpur before the commencement
 of the counselling process.
- Out of total seats 85% will be for candidates from Punjab State, whereas the remaining 15% seats will be open for candidates from any other state/UT of India.

- 8. A candidate from reserved Category shall have the right to compete for admission in General /Unreserved category seats as per his/her merit on the day of counselling and candidate so selected shall not be counted towards admission in the reserve category.

The resident status of Punjab state shall be taken in terms of Punjab Government, Department of Personnel and Administrative reforms (PP-II Branch) letter No. 1/3/95-3 PP II/9619, dated 6th June, 1996, ID No.1/2/96-3PP-2/8976,dated 7th July,1998 and ID No.1/3/95-3PP/II/81, dated 1st January 1999 and any further instructions issued by the Department of Personnel, if any, and the same shall be adhered to. Candidate must have passed 10+1 and 10+2 examination from Punjab. Candidate who passed his/her 10+1 and 10+2 examinations or other equivalent examination from a recognized School/Institution situated in Chandigarh (Union Territory), who is bonafide resident of Punjab shall also be eligible.

The following categories shall be exempted from this condition:-

Government employees, members of All India Services borne on Punjab cadre, Serving Judges and the employees of the Hon'ble Punjab and Haryana High Court, employees of Boards/Corporations/Statutory Bodies established by an Act of the State of Punjab who have been holding posts outside Punjab on or before 1st January of the year of passing 10+2 examination and their children/wards/dependants have passed class XI and/or XII examinations from outside Punjab.



- Government employees, employees of Boards/Corporations/Statutory Bodies of the Central Government who have remained posted inside Punjab for at least two years out of the three years preceding year of passing 10+2 examination but were posted outside Punjab for some time during these three years due to which their children/wards/dependants have passed class XI and/or XII or equivalent qualifying examinations from outside Punjab. However those who remained posted in Punjab continuously for these three years shall not be entitled to be exempted as they are equally placed with other Punjab Government employees posted in Punjab.
- Government pensioners who have retired on or before 1st January of the year of passing 10+2 examination and have settled outside Punjab on or before 1st January of the year of the year of passing 10+2 examination and their children/wards/dependants have passed class XII examination from outside Punjab.

- iv) Children/wards/dependents (whose parents are not alive) of those military/para-military forces personnel who are born or belong to the State of Punjab as per their service record at the time of entry into service.
- v) Children/wards/dependents (whose parents are not alive) of those Ex-employees of military/ Para military forces who are born or belong to State of Punjab as per their service record at the time of entry into the service and have retired on or after 1st January of the year preceding two years of the year of passing 10+2 examination.
- vi) Candidates belonging to minority community who are competing for the minority quota in the minority institutions.
- vii) Candidates seeking admission under NRI category.
- viii) Wards of defence personnel posted in Punjab.

Provided however, that in case adequate numbers of candidates from Punjab are not available for BAMS/BHMS/BUMS course, then other States candidates may be considered for admission in Punjab quota, strictly as per NEET merit.

In view of the judgment dated 02.07.2014 in CWP No. 6009 of 2014 and connected cases by the Hon'ble Punjab and Haryana High Court, the eligibility criteria from academic session 2019-2020 onwards shall be, inter-alia as under:-

"The candidate shall have passed his/her 10th Class examination and also 10+1 and 10+2 from the State of Punjab."





No. 24-14/2018 (UG Regulation).—In exercise of the powers conferred by clauses (i), (j) and (k) of sub-section (1) of section 36 of the Indian Medicine Central Council Act, 1970 (48 of 1970), the Central Council of Indian Medicine, with the previous sanction of the Central Government, hereby makes the following regulations further to amend the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Regulations, 1986, namely:—
 - Short title, commencement and application.—(1) These regulations may be called the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Amendment Regulations, 2018.
 - (2) They shall come into force on the date of their publication in the Official Gazette.
 - (3) These regulations shall apply to students who shall be admitted for B.A.M.S., B.S.M.S. and B.U.M.S from the commencement of the academic session (2019-2020).
 - In the Indian Medicine Central Council (Minimum Standards of Education in Indian Medicine) Regulations, 1986 (hereinafter referred to as the said regulations) in Schedule-I, for regulation 2, the following regulation shall be substituted, namely:-
 - "2. Eligibility for Admission.- The eligibility to seek admission in Bachelor of Ayurveda education shall be as under:-
 - (a) The candidate must have passed intermediate (10+2) or its equivalent examination recognised by the concerned State Government and Education Board with the subjects of Physics, Chemistry, Biology and English individually and must have obtained minimum of fifty per cent. marks taken together in Physics, Chemistry and Biology at the aforesaid qualifying examination in the case of general category and forty per cent. Marks in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes.

- (b) In respect of persons with disability candidate specified under the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the minimum qualifying marks in the said qualifying examination in Physics, Chemistry and Biology shall be forty-five per cent. in the case of general category and forty per cent. in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes.
- (c) No candidate shall be admitted to B.A.M.S Degree Course unless he has attained the age of seventeen years on or before the 31st December of the year of his admission in the first year of the course and not more than of twenty-five years on or before the 31st December of the year of admission in the first year of the course:

Provided that the upper age limit may be relaxed by five years in the case of the Scheduled Castes, Scheduled Tribes, Other Backward Classes and physically handicapped candidates.

- (d) (i) There shall be a uniform entrance examination for all medical institutions at the under-graduate level, namely the National Eligibility Entrance Test (NEET) for admission to under-graduatecourse in each academic year and shall be conducted by an authority designated by the Central Government.
- (ii) In order to be eligible for admission to under-graduate course for an academic year, it shall be necessary for a candidate to obtain minimum of marks at 50th percentile in the 'National Eligibility Entrance Test for undergraduate course' held for the said academic year:

Provided that in respect of-

- (A) candidates belonging to the Scheduled Castes, Scheduled Tribes and Other Backward Classes, the minimum marks shall be at $40^{\rm th}$ percentile;
- (B) candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the minimum marks shall be at 45^{th} percentile in the case of general category and 40^{th} percentile in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes.

Explanation.—The percentile shall be determined on the basis of highest marks secured in the all India common merit list in the National Eligibility Entrance Test for under-graduate courses:

Provided further that when sufficient number of candidates in the respective categories fail to secure minimum marks in the National Eligibility Entrance Test, as specified above, held for any academic year for admission to under-graduate courses, the Central Government in consultation with the Central Council may at its discretion lower the minimum marks required for admission to under-graduate course for candidates belonging to respective categories and marks so lowered by the Central Government shall be applicable for that academic year only.

- (iii) An all India common merit list as well as State-wise merit list of the eligible candidates shall be prepared on the basis of the marks obtained in the National Eligibility Entrance Test and the candidates, within the respective categories, shall be admitted to under-graduate course from the said merit lists only.
- (iv) The seat matrix for admission in the Government, Government-aided Institutions and Private Institutions shall be fifteen per cent. for the all India quota and eighty-five per cent. for the States and Union territories quota.
- (v) The designated authority for counseling for all admissions to under-graduate course in all Ayurveda educational institutions in the States and Union territories including institutions established by the State Government, University, Deemed University, Trust, Society, Minority Institution, Corporation or Company shall be the respective State or Union territory in accordance with the relevant rules and regulations of the concerned State or Union territory Government, as the case may be.
- (vi) The counseling for all admission to B.A.M.S Course for seats under all India quota as well as for all Ayurveda educational institutions established by the Central Government shall be conducted by the authority designated by the Central Government.
- (vii) No candidate who has failed to obtain the minimum eligibility marks as specified above shall be admitted to under-graduate course in the said academic year.
- (viii) No authority or institution shall admit any candidate to the under-graduate course in contravention of the criteria or procedure as laid down by these regulations in respect of admissions and any candidate admitted in contravention of the said criteria or procedure shall be discharged by the Central Council forthwith.
- (ix) The authority or institution which grants admission to any student in contravention of the aforesaid criteria or procedure shall be liable to face action in terms of the provisions of the Act.
- (e) For foreign national candidate any other equivalent qualification to be approved by the Central Government may be allowed and clause (d) shall not be applicable for said foreign national candidate.".

 - (2) They shall come into force on the date of their publication in the Official Gazette.
- (3) These regulations shall apply to students who shall be admitted for B.H.M.S. (Degree Course) from the commencement of the academic session (2019-2020).

- 2. In the Homoeopathy (Degree Course) Regulations, 1983 (hereinafter referred to as the said regulations), in regulation 4,-
- (a) in sub-regulation (i), the following proviso shall be inserted, namely:- "Provided that-
- (i) the candidate must have passed in the subjects of Physics, Chemistry, Biology and English individually and must have obtained a minimum of fifty per cent. marks taken together in Physics, Chemistry and Biology at the qualifying examination mentioned above for unreserved candidates and forty per cent. marks in respect of the Scheduled Castes, Scheduled Tribes and Other Backward Classes;
- (ii) candidate with benchmark disabilities as specified under the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the minimum qualifying marks in qualifying examination in Physics, Chemistry and Biology shall be forty-five per cent. for general category and forty per cent. for the Scheduled Castes, Scheduled Tribes and Other Backward Classes.";
- b) for sub-regulation (ii), the following sub-regulation shall be substituted, namely:-
 - "(ii) No candidate shall be admitted to B.H.M.S. Degree Course unless he has attained the age of seventeen years on or before the 31st December of the year of this admission in the first year of the course and not older than the age of twenty-five years on or before the 31st December of the year of admission in the first year of the course:

Provided that the upper age limit may be relaxed by five years to the Scheduled Castes,

Scheduled Tribes, Other Backward Classes and physically handicapped candidates.".

- 3. In the said regulations, in regulation 4A, for sub-regulation (i), the following sub-regulation shall be substituted, namely:-
- "(i) There shall be a uniform entrance examination to all medical institutions at the undergraduate level, namely the National Eligibility Entrance Test (NEET) for admission to undergraduate course in each academic year and shall be conducted by an authority designated by the Central Government;
- (ii) In order to be eligible for admission to undergraduate course for an academic year, it shall be necessary for a candidate to obtain minimum of marks at 50th percentile in the 'National Eligibility Entrance Test for undergraduate course' held for the said academic year:

Provided that in respect of-

- (a) candidates belonging to the Scheduled Castes, Scheduled Tribes and Other Backward Classes, the minimum marks shall be at 40th percentile;
- (b) candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the minimum marks shall be at 45th percentile for General Category and 40th percentile for the Scheduled Castes, Scheduled Tribes and Other Backward Classes.

Explanation. – The percentile shall be determined on the basis of highest marks secured in the all India common merit list in the National Eligibility Entrance Test for undergraduate courses:

Provided further that when sufficient number of candidates in the respective categories fail to secure minimum marks in the National Eligibility Entrance Test, as specified above, held for any academic year for admission to undergraduate courses, the Central Government in consultation with Central Council may at its discretion lower the minimum marks required for admission to undergraduate course for candidates belonging to respective categories and marks so lowered by the Central Government shall be applicable for that academic year only.

- (iii) An all India common merit list as well as State-wise merit list of the eligible candidates shall be prepared on the basis of the marks obtained in the National Eligibility Entrance Test and the candidates, within the respective categories, shall be admitted to undergraduate course from the said merit lists only.
- (iv) The seat matrix for admission in the Government, Government-aided Institutions and Private Institutions shall be fifteen per cent. for the all India quota and eighty-five per cent. for the States and Union territories quota.
- (v) The designated authority for counseling for all admissions to undergraduate course in all Homoeopathy educational institutions in the States and Union territories including institutions established by the States Government, University, Deemed University, Trust, Society, Minority Institution, Corporation or Company

shall be the respective State or Union territory in accordance with the relevant rules and regulations of the concerned State or Union territory Government, as the case may be.

- (vi) The counseling for all admissions to undergraduate course for seats under the all India quota as well as for all Homoeopathy educational institutions established by the Central Government shall be conducted by the authority designated by the Central Government.
- (vii) No candidate who has failed to obtain the minimum eligibility marks as specified above shall be admitted to undergraduate course in the said academic year.
- (viii) No authority or institution shall admit any candidate to the undergraduate course in contravention of the criteria or procedure as laid down by these regulations in respect of admissions and any candidate admitted in contravention of the said criteria or procedure shall be discharged by the Central Council forthwith.
- (ix) The authority or institution which grants admission to any student in contravention of the aforesaid criteria or procedure shall be liable to face action in terms of the provisions of the Act.
- (x) For foreign national candidates any other equivalent qualification to be approved by the Central Government may be allowed, and entrance examination for admission to undergraduate course namely the National Eligibility Entrance Test (NEET) shall not be applicable for foreign national candidates.
- In the said regulations, in regulation 6, under the heading "Fourth B.H.M.S.", under sub-heading "C. Examination", for part "2. Practical including viva voice or oral" and the entries relating there to, the following shall be substituted, namely:-
- "2. Practical including viva voce or oral"
 - 2.1. Marks: 200

2.2. Distribution of marks:	Marks
2.2.1. One long case	40
2.2.2. One short case	20
2.2.3. Practical records, case records, journal	15
2.2.4. Identification of specimens	25
(X-ray, E.C.G., etc.)

- In the said regulations, in regulation 11, in sub-regulation (iii), for clause (c), the following clause shall be substituted, namely:-
 - "(c) The candidate shall pass First BHMS Examination in all the subjects at least one term (six months) before he is allowed to appear in Second BHMS Examination.".

- ii. Counseling for all India quota seats of ASU&H UG & PG courses of Private Institutions other than Deemed Universities under their jurisdiction shall be conducted by respective counseling authority of State/UT Government.
- iii. The guidelines for conduction of Counseling of All India Quota UG & PG seats of Private ASU & H institutes other than Deemed Universities for academic year 2021-22 are annexed (copy enclosed).

Guidelines for Counseling of All India Quota seats of UG (BAMS/BSMS/BUMS/BHMS) courses & PG (MD/MS) courses of Private Ayurveda, Siddha, Unani & Homoeopathy Institutes for the academic year 2021-22.

- (i). State/UT counseling authorities shall conduct minimum Two Round of counseling for all India quota (AIQ) UG & PG seats of Private ASU & H Institutes and after 02nd Round, if AIQ seats are not filled, these vacant seats may be converted into the State/UT Government quota seats and same will be filled up as per State Government rules.
- (ii). State/UT counseling authorities should give wider publicity for registration process & provide sufficient time to NEET-UG 2021/AIAPGET-2021 qualified aspirants for registration before each round of counseling for AIQ UG & PG seats of Private ASU & H Institutes. Details of the same may be shared with AACCC, Ministry of Ayush on mail id counseling-ayush@gov.in
- (iii). State/UT may decide an all-inclusive application Cost/Non-refundable Registration Fee for UG & PG seats for all category students. However, maximum ceiling limit for this fee will be Rs 2000/-.
- (iv). State/UT may decide refundable security money which will be refunded to candidates after joining the allotted college or if candidate did not get any seat during counseling. However, maximum ceiling limit for this fee will be Rs. 50,000/for UG & PG seats.
- (v). The Security money will be forfeited if a candidate who has been allotted a seat in the 2nd/Mop-Up Round and does not join the respective institution or surrender the seat due to any unforeseen reason. Also the Security Money will be forfeited if the admission gets cancelled due to any reason on the part of student. i.e in case the candidate gives wrong information at the time of registration on the basis of which a seat may be allotted and later cancelled by the Admission Authorities at the time of reporting or fails to produce the required documents at the time of admission (within the stipulated time).

- (vi). Candidates admitted in 2nd/Mop-Up Round of All India Quota Private UG & PG counseling can leave/surrender their admitted seat with forfeiture of security money only during specific time period provided by State/UT authority. (State/UT authorities can decide this time period to leave/surrender admitted seat after 2nd/Mop-Up Round as per their counseling schedule) After the said period, candidate will not be allowed to leave/surrender their admitted seat and also will be ineligible for any further counseling.
- (vii). There will be no requirement for any domicile certificate for allotment of seat in AIQ UG & PG seats of Private ASU & H Institutes.
- (viii). Reservation for allotment of AIQ UG & PG seats in Private ASU & H Institutes: all AIQ UG & PG seats of Private ASU & H Institutes are open in nature. However, relaxation in qualifying criterion may be provided category wise as mentioned in relevant regulations.
- (ix). Qualification Criterion: (As per the ASU & H UG & PG Regulations, 2018)
 a. For Admission in UG (BAMS/BSMS/BUMS/BHMS) Courses: Passing marks for eligibility in admission to ASU & H UG courses should be as per the ASU & H UG regulations and should be followed strictly. The details qualifications for different categories are as follows:
 - The candidate must have passed intermediate (10+2) or its equivalent examination recognized by the concerned State Government and Education Board with the subjects of Physics, Chemistry, Biology and English individually.
 - Minimum of 50% marks taken together in Physics, Chemistry and Biology at the aforesaid qualifying examination in the case of General Category.
 - 40% Marks in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes.
 - iv. In respect of persons with disability candidate specified under the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the minimum qualifying marks

in the said qualifying examination are as follows: a) In Physics, Chemistry and Biology shall be 45% in the case of general category. (For PwD candidates only) b) 40% in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes. (for PwD candidates only).

- v. In order to be eligible for admission to under-graduate course for an academic year, it shall be necessary for a candidate to obtain minimum of marks at 50th percentile in the 'National Eligibility Entrance Test for undergraduate course' held for the said academic year: Provided that in respect of- (A) candidates belonging to the Scheduled Castes, Scheduled Tribes and Other Backward Classes, the minimum marks shall be at 40th percentile; (B) candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the minimum marks shall be at 45th percentile in the case of general category and 40th percentile in the case of the Scheduled Castes, Scheduled Tribes and Other Backward Classes.
- b. For admission to ASU&H PG (MD/MS) Courses: Passing marks for eligibility in admission to ASU & H PG courses should be as per the ASU & H PG regulations and should be followed strictly. The details qualifications for different categories are as follows:
 - i. The candidate must have passed final year UG examination from a recognized University or Board or medical institution specified in the Schedules to the Act and enrolled in Central or State register of Indian System of Medicine and must have completed satisfactorily one year compulsory rotating internship as on or before 31.12.2021 (for academic year 2021-22 only)
- ii. In order to be eligible for admission to post-graduate courses for an academic year, it shall be necessary for a candidate to obtain minimum of marks at 50th percentile in the All India Ayush Post Graduate Entrance Test, 2021 (AIAPGET-2021): Provided that in respect of- (a) candidates belonging to the Scheduled Castes, Scheduled Tribes and Other Backward Classes, the minimum marks shall be at 40th percentile; (b) candidates with benchmark disabilities specified under the Rights of Persons with Disabilities Act, 2016 (49 of 2016), the minimum marks shall be at 45th percentile for the General Category and 40th percentile for the Scheduled Castes, Scheduled Tribes and Other Backward Classes.

(x). For PwD candidates, PwD certificate should be as per the guidelines issued by Central Government and notified. (available on counseling website namely www.aaccc.gov.in under Counseling Scheme & FAQs)

I am directed to invite your attention to the Punjab Government Circular Letter No.1/3/95-3PP II/2043, dated 29/1/1996 vide which the instructions were issued regarding simplification of procedure for obtaining the certificate of Domicile for purposes of admission to educational institutions (including technical/medical institution). The matter has been reconsidered in the light of judgement delivered by the Hon'ble Supreme Court of India in the case of Dr. Pradeep Jain Vs. Union of India and others reported as AIR 1984-SC-4121 wherein it was held that instead of the word 'Domicile' the word 'Residence' be used in the instructions issued by the State Government on the subject. Accordingly, it has been decided by the Government to revise the Government instructions referred to above as under:

- (a) Citizen of India
- (b) Produce an affidavit to the effect that they or their Children/wards have not obtained the benefit of Residence in any other State

- In pursuance of insertion of Article 15(6) and Article 16(6) in the Constitution of India vide the Constitution (One hundred and third Amendment) Act, 2019, the Ministry of Social Justice & Empowerment, Govt. of India has issued policy vide O.M. No.F.No.20013/01/2018-BC-II dated 17.01.2019 to provide 10% reservation in civil posts and services in Govt. of India and admission in Educational Institutions to Ecomonically Weaker sections (EWSs) who are not covered under the existing scheme of reservation for the Scheduled Castes, Scheduled Tribes and the Socially and economically Backward Classes.
- On the basis of O.M dated 17.01.2019, DoPT vide OM F. NO. 36039/01/2019-EStt.(Res)-II dated 19.01.2019 has notified that 10% reservation would be provided for Economically Weaker Sections (EWSs) in central government posts and services. DoPT vide OM F. NO. 36039/01/2019-EStt.(Res)-II dated 31.01.2019 has inter-alia issued detailed instructions regarding procedure for implementation of EWS reservation. The copies of the OM 19.01.2019 and OM 31.01.2019 is available https://dopt.gov.in/notifications/oms-and-orders which may be referred to.
- Similarly, Ministry of HRD vide OM F.No. 12-4/2019-U1 dated 17.01.2019 has issued instructions to provide reservation in admission to Central educational institutions. This OM is available on the link https://www.ugc.ac.in/ugc_notices.aspx.
- In view of these instructions, the following persons are eligible for being issued the Income & Assets Certificate for availing the benefit of reservation for Economically Weaker Sections for admission to Central Educational Institutions and for Central Govt. posts and Services:-
 - Persons who are not covered under the scheme of reservation by Govt. of india for SCs, STs and OBCs and
 - Whose gross family income is below Rs. 8.00 lakh (Rs. Eight lacs only) per annum. Income shall include income from all sources i.e. salary, agriculture, business profession etc. for the financial year prior to the year of application.
 - All persons whose family owns or possesses any of the following assets shall be excluded from being identified as EWSs, irrespective of the family

- i. S acres of Agricultural Land and above;
- ii, Residential flat of 1000 sq, ft. and above;
- iii. Residential plot of 100 sq. yards and above in notified municipalities;
- Residential plot of 200 sq. yards and above in areas other than notified municipalities.
- d) The property held by a "Family" in different locations or different places/cities would be clubbed while applying the land or property holding test to determine EWS status.
- e) The term "Family" for this purpose will include the person who seeks benefit of reservation, his/her parents and siblings below the age of 18 years as also his/her spouse and children below the age of 18 years.
- 6. It has been decided that the applicant will present an application and self declaration as per Annexure-A and B respectively. The certificate will be issued as per specimen given in Annexure -C and will be valid for the financial year in which it is issued.
- 7. The concerned Tehsildar will be the Income and Assets Certificate issuing authority. He will issue the certificate after carefully verifying the claim and all relevant documents.
- In special circumstances, the Deputy Commissioner may, by an order in writing, authorise the Sub-Divisional Magistrate of the area to issue the certificate.

 - (iii) The number of permitted colleges may increase/decrease. The final list of permitted colleges/category wise seat distribution will be displayed at the time of counseling.
